### HONOURS AND AWARDS

#### HOME OFFICE

The QUEEN has been pleased to award The Queen's Police Medal for Gallantry to the late Constable George William McKinley Russell of the Cumberland, Westmorland and Carlisle Constabulary in the following circumstances:

A dangerous criminal armed with a revolver, who had already escaped capture by firing at police officers who had cornered him, was located at Oxenholme Railway Station by a party of five police officers, among whom was Constable Russell.

The man was seen lying on a bench in the waiting room of the station. Constable Russell who was wearing a civilian overcoat over his uniform volunteered to enter the waiting room first. He called on the man to surrender and was immediately shot and subsequently died. An Inspector who followed him was also shot and wounded and after wounding a third officer, the man escaped along the railway line.

Subsequently a cordon was drawn round the area and the man, after being wounded, turned his weapon on himself.

Constable Russell knew of the risk that he might be shot but though unarmed himself did not hesitate to enter the room and call on the man to surrender. His courage and devotion to duty are in the highest traditions of the service.
