MINISTRY OF DEFENCE

The QUEEN has been graciously pleased on the advice of Her Majesty's Australian Ministers to approve the undermentioned awards in recognition of Gallant and Distinguished Services in Vietnam:

Distinguished Service Order

Colonel Francis Philip SERONG, O.B.E. (3102), Australian Staff Corps.

Colonel Serong graduated from the Royal Military College in December 1937, and has served continuously since that date.

In July 1962, in response to an invitation from the Government of South Vietnam an Australian Army Training Team was sent from Australia to assist in training Vietnamese in jungle warfare, village defence and related activities. Colonel Serong was chosen as the Commander of the Team.

Subsequently, when the role of the Team was widened to permit members to accompany the Vietnamese forces, by the very nature of the conflict our members became involved in operations which called for a high standard of courage, skill and leadership. Casualties have been sustained by our forces.

Colonel Serong's outstanding courage and devotion to duty has set an example which has been an inspiration to all those who come in contact with him. He has at all times maintained close personal touch with members serving on outstations and during these visits has, on occasions, become involved in clashes in which his courage and leadership have contributed significantly to the success of operations.

In the 2½ years as Commander, he has maintained the high tradition of the Australian Army and has brought honour to his country as its representative. He is held in the highest regard by the United States and Vietnamese Authorities. Colonel Serong is to relinquish the appointment in February 1965.

Military Cross

Captain Arthur Barry PETERSEN (13668), Royal Australian Infantry.

Captain Petersen graduated from the Officer Cadet School at Portsea on the 17th December 1954. Since his graduation, Captain Petersen has served as a platoon commander with National Service Trainees and as a platoon commander with the First Battalion Royal Australian Regiment. Captain Petersen's service with the First Battalion Royal Australian Regiment included three years service in Malaya from 1959 to 1961. Captain Petersen was a company second-in-command with the First Recruit Training Battalion at Kapooka until his assignment to the

Australian Army Training Team Vietnam in August 1963.

Captain Petersen's assignment as a member of the Australian Army Training Team Vietnam, involves advice on the administration, training and operational employment of Montagnard personnel in Darlac province. He was so occupied when the Montagnard Revolt of September 1964 broke out.

During this revolt, in which several thousand heavily armed Montagnard soldiers were deployed against the provincial capital of Ban Me Thuot, Captain Petersen was required to prepare for the initial contact with the rebel 'ribesmen'. On the afternoon of the 20th September 1964, the first day of the revolt, he conducted a small party of intermediaries to the hamlet of Boun Enou. This involved passing through a prepared ambush. Having detected this, he dismounted from his vehicle, located the ambush commander, and persuaded him to permit the party's onward movement. He was then required to approach the rebel stronghold and obtain admittance for the party. This he did, in gathering darkness and under conditions of extreme sensitivity involving a high degree of personal risk. Having gained admittance, by his own powers of persuasion he brought together the local leaders for talks with the intermediaries.

The talks were successful, and paved the way for the eventual peaceful return of the Montagnard personnel to their proper duties. This most fortunate outcome is substantially attributable to the personal influence of Captain Petersen, and to the high degree of courage displayed by him in effecting the necessary contacts.

Distinguished Conduct Medal

3975 Warrant Officer Class I George Ernest CHINN, Royal Australian Infantry.

Warrant Officer Class I George Ernest Chinn served with both the Australian Military Forces and the Royal Australian Air Force during World War II. At the conclusion of the war he continued his service as an infantry soldier in the 22nd Battalion and the Royal Australian Regiment. He was an instructor at the Royal Military College, Duntroon, from 1952 to 1960 when he was appointed Regimental Sergeant Major of the 1st Special Air Service Company, Royal Australian Infantry. In April 1964 Warrant Officer Chinn joined the Australian Army Training Team in Vietnam and was posted as an advisor at the Dong Da National Training Centre in Thua Thien Province.

While temporarily detached from the Training Centre he accompanied the 32nd Vietnamese Ranger Battalion during operation LAM SON 115 near Lavang from the 18th to 28th April 1964.

During the helicopter assault landing, Warrant Officer Chinn landed in the first wave under Viet Cong ground fire which caused several casualties. Realising the effect this fire would have on the second wave of troop loaded helicopters, he assisted in the deployment of sub units and the clearing of the Viet Cong out of range of the landing zone with complete disregard for his own safety and in the face of Viet Cong fire. The second wave were able to land without casualties.

Immediately after the Ranger Force had cleared the Viet Cong training camp they were again attacked by the Viet Cong. Warrant Officer Chinn personally drew Viet Cong fire, allowing the organisation of a successful reaction force.

Distinguished Conduct Medal

24492 Sergeant (Temporary Warrant Officer Class II) Rayene Stewart SIMPSON, Royal Australian Infantry.

Warrant Officer Simpson served with the Australian Imperial Forces from March 1944 to January 1947. He re-enlisted in January 1951, serving with the Royal Australian Regiment during 1951 and in Malaya during the emergency.

Warrant Officer Simpson was assigned to the first Australian Army Training Team Vietnam in August 1962 and returned to Australia in August 1963. He volunteered for a second tour with the Australian Army Training Team Vietnam and was assigned to the training team on the 13th July 1964, from the First Special Air Service Company.

He was immediately posted to the advisory group with United States and Vietnamese Special Forces in the mountainous jungles of the North West. Shortly after his arrival, he took a major part in the establishment of a new patrol base at Tako, designed to control border infiltration; and thereafter his task was to provide advice in the training and operations of Vietnamese patrols from that base. On one such patrol, led by a Vietnamese Special Forces Officer the platoon size group was intercepted by a superior Viet Cong force. The Vietnamese leader was an early casualty. Warrant Officer Simpson was severely wounded by rifle fire in the right leg. Despite his wound, he rallied the platoon, formed a defensive position, contacted base by radio, and, by personal example and inspiring leadership, held off repeated assaults by the Viet Cong force, until, with ammunition almost exhausted, and himself weak from loss of blood, the relief force he had alerted arrived at the scene. Even then, not until he was satisfied that the position was secure and the troops of his patrol adequately cared for did he permit himself to be evacuated.
