

## HORSHAM URBAN DISTRICT COUNCIL

*Horsham Urban District**North Street (Restriction of Waiting) Order, 1965*

Notice is hereby given that the Horsham Urban District Council propose to make an Order under sections 26 and 27 of the Road Traffic Act 1960 the effect of which will be to prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays (inclusive).

(i) except for a period of not more than three hours together at any one time in the following lengths of North Street:

(a) on the south-eastern side of North Street from a point 100 feet north-east of the junction of the eastern arm of North Street with Park Street to a point 955 feet north-east of that point the following lengths north-east from the first mentioned point:

250 feet to 335 feet	85 feet
405 feet to 645 feet	240 feet
715 feet to 805 feet	90 feet
870 feet to 935 feet	65 feet

(b) on the north-western side of North Street from a point 705 feet north-east from the north-easterly side of the junction of Linden Road with North Street to a point 1,102 feet north-east of that point the following lengths north-east from the first mentioned point:

587 feet to 747 feet	160 feet

(ii) (a) In the section of North Street specified in paragraph (i) (a) above the following lengths from the therein first mentioned point:

from 180 feet to 250 feet	70 feet
335 feet to 405 feet	70 feet
645 feet to 715 feet	70 feet
935 feet to 955 feet	20 feet

(b) in the section of North Street specified in paragraph (i) (b) above the following lengths from the therein first mentioned point:

from that point to 210 feet	210 feet
522 feet to 587 feet	65 feet
747 feet to 1,102 feet	355 feet

Exceptions will be provided in the Order to enable vehicles to stop to pick up and set down passengers, goods or merchandise, and to wait when engaged on the repair of roads or the services therein, or to take in petrol, oil, air or water from a garage and in connection with funerals.

## ISLE OF WIGHT COUNTY COUNCIL

*The County of The Isle of Wight (Various Streets, Brading) (No Waiting) Order, 1965*

Notice is hereby given that the Isle of Wight County Council propose to make an Order under sections 26 and 27 of the Road Traffic Act 1960 the effect of which will be to prohibit the waiting of vehicles subject to the usual exemptions in the following lengths of roads:

New Road (A.3055) from a point 100 yards south to a point 80 yards north of Yarbridge Cross.	Both.
Mall Road from its junction with Yarbridge Cross to a point 100 feet west of that junction.	Both.
Marshcombe Road from its junction with Yarbridge Cross to a point 100 feet east of that junction.	Both.
New Road (A.3055) from a point 230 feet south of its junction with Wrax Road to a point 530 feet south of that junction.	Both.
The Bull Ring (A.3055) and extending 80 yards southwards in Mall Road, 50 yards northwards in High Street and to the southern boundary of Berrys Garage in New Road.	Both.
High Street (A.3055) from a point 50 yards north of the Bull Ring to its junction with Broadstone Crescent.	West.
Wall Lane, from its junction with the High Street to a point 50 yards east of that junction.	Both.
