

## SECOND SCHEDULE

The Orders referred to hereunder will prohibit the driving of any vehicle the width of which, inclusive of any load, exceeds 6 feet 6 inches on the lengths of road specified under the title to each Order.

Exceptions are provided in the Orders to enable any vehicle to be used on any of the roads concerned with the permission of a police constable in uniform or (if not a public service vehicle) when being used for the conveyance of persons, goods or merchandise to or from any premises situated on those roads, or in connection with agriculture, timber haulage, any building operation or demolition, the removal of any obstruction to traffic, the maintenance of those roads or the services therein.

A further exception is provided in the Order numbered (i) to enable there to be driven along the roads concerned any stage carriage of such width as shall have been authorised by the Traffic Commissioners for the South-Eastern Traffic Area for use on those roads.

Eastry Rural ... ..	W.12	The unclassified road leading from its junction with the Westmarsh-Richborough Road, near Richborough Farm, Ash, via Cooper's Street, Brookstreet Farm, and Twitham Court to its junction near the Brewery, Ash, with the Canterbury-Sandwich Road (A.257) including the following branch roads: <ol style="list-style-type: none"> <li>(i) from the road junction approximately 500 yards south of Brookstreet Farm via Goss Hall to the junction near the Collar Maker's Hole with the Canterbury-Sandwich Road (A.257), and</li> <li>(ii) from the road junction near Goss Hall to the junction with the Canterbury-Sandwich Road (A.257) approximately 600 yards west of the Red Lion Inn at Each End.</li> </ol>

Bridge-Blean Rural ... ..	W.5	The unclassified road which leads from its junction with the Shalmsford Street-Lower Hardres Road (Class III) at St. Augustine's Hospital, Chartham, via Garlinge Green to its junction with the Canterbury-Waltham Road (Class III) at Petham.

Cranbrook Rural ... ..	W.8	The unclassified road leading from the Iden Green-Sandhurst Road (Class III) at Sponden, Sandhurst, to its junction at Field Green with the Field Green-Hinxden Bridge Road (unclassified).
Cranbrook Rural and Tenterden Rural ...	W.9	The unclassified road leading from the East End-Stepneyford Bridge Road near Backtilt Wood, Benenden, via Mount Pleasant and Halden Place, Rolvenden, to its junction at Rolvenden with the Margate-Hastings Road, A.28.
Cranbrook Rural and Tenterden Rural ...	W.10	The unclassified road leading from the Flimwell-Rye Road (A.268) at the Manse, Sandhurst, via Hoad's Farm Hope House, Dingledden in the Parish of Benenden, and Ramsden to its junction near Beacon Hill with the Hartley-Rolvenden Road (B.2086), Benenden, including the branch road via Devenden to the junction at West Cross with the Hartley-Rolvenden Road (B.2086), Rolvenden.
