#### *Cotton Waste Reclamation Wages Council (Great Britain)*

E.C.2. Details of the boundaries of the areas covered by the licences, described from the 2½" Ordnance Survey Maps and with reference to the National Grid, are given in the Schedule below.

#### SCHEDULE

*An area of 184 square miles in the county of  
Lancaster*

#### *Northern Boundary*

From the point SD30715057 the boundary follows the Low Water Mark of Ordinary Tides eastwards to the point SD32655124 then crosses the River Wyre in a straight line to the point SD32955132, thence continues eastwards along the Low Water Mark of Ordinary Tides to the point SD45215639 on the south side of the River Lune. From this latter point the boundary follows the south side of the River Conder to the railway, thence along the south side of the road to the point SD45965597 then crosses the A.588 road and continues eastwards along the footpath to the point SD46035595, thence eastwards along the road, via Sellerley and Ellel Hall, to its junction with the A.6 road at Galgate.

#### *Eastern Boundary*

From Galgate the boundary follows the A.6 road southwards to its junction with the B.6430 road at the point SD49064666, thence along the B.6430 to its junction with the A.6 at the point SD50264196, thence southwards along the A.6 to the railway at the point SD51443810 and continues southwards along the railway to the point SD52733097 (Addison Road) in Preston. From this latter point the boundary follows Addison Road westwards to its junction with the A.583 road, thence south-eastwards along the A.583 to its junction with the A.5072 road at the point SD52432999, thence southwards along the A.5072 to its junction with the A.59 road at the point 52872890.

#### *Southern Boundary*

From the point SD52872890 the boundary follows the A.59 road south-westwards to the point SD50482721 then follows Mill Brook north-westwards to the point SD49022885 on the south side of the River Ribble, thence by a straight line across the river to the point SD49002898. From this point the boundary continues westwards along the north side of the River Ribble to the point SD48152877, thence along Savick Brook to Savick Bridge. From Savick Bridge the boundary follows the A.583 road westwards to its junction with the A.584 road, thence along the A.584 to the point SD43712941 thence northwards and westwards along the road via Higher House, Cooper House Farm, Hillock Lane, Kella-mergh and Bryning, to the point SD39603131 at Wrea Green. From this latter point the boundary follows the B.5259 road westwards to the point SD37503020, thence along the road via Higher Ballam Bridge to the point SD35883118, thence along Anna's Road and Wild Lane to Red Bridge, thence westwards along the road via the points SD33733201, SD33403260, SD32723249 and SD32763231 to its junction with the B.5262 road at the point SD31203186, thence continues westwards along the B.5262 to the point SD30613170. From this latter point the boundary follows a straight line to the point SD29803146 on the Low Water Mark of Ordinary Tides.

#### *Western Boundary*

From the point SD29803146 the boundary follows the Low Water Mark of Ordinary Tides northwards to the point SD30715057.

This area was previously included in the area described in the *London Gazette* dated 6th June 1950.

#### *Northern Boundary*

From the point SK42979285 in Rotherham the boundary follows the A.6021 road eastwards to its junction with the A.631 road at the point SK46059162, thence it continues eastwards along the A.631 via Maltby and Tickhill to the point SK65049306, thence northwards along the road to the point SK65079322, thence eastwards along the road to its junction with the A.614 road at the point
