REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES**PAY AND HOURS IN BREAD DISTRIBUTION**

Negotiations have been taking place between the Federation of Wholesale and Multiple Bakers of England and Wales and the unions concerned on claims for increases in pay and reductions in hours for workers engaged in bread distribution in England and Wales. The employers and the union concerned (United Road Transport Union) in the Greater London, South-East and Southern Areas and the East Midlands, North-Eastern and North-Western Areas have jointly requested that the Union's claims should be referred to the National Board for Prices and Incomes.

2. The Government consider it desirable in the national interest that the N.B.P.I. should urgently investigate and report on the wages situation including the wages structure in the baking industry. As the Board have only recently reported on costs and prices in the industry (Cmnd. 2760), the Government are asking the Board to consider making an interim report before the end of the year on these wage claims without prejudice to their ultimate findings.

3. The Board are accordingly requested to put in hand these inquiries.

REFERENCE TO THE NATIONAL BOARD FOR PRICES AND INCOMES**WAGES IN THE BAKING INDUSTRY**

Negotiations have been taking place between the Federation of Wholesale and Multiple Bakers of England and Wales and the Bakers' Union on a claim for an increase in the basic weekly wage rate but have not resulted in agreement. A settlement has recently been reached in Scotland by the National Joint Committee for the Scottish Baking Industry for an increase of 20s. a week from 2nd January 1966 and a 40 hour 5 day week from 6th March 1966.

2. The Government consider it desirable in the national interest that the N.B.P.I. should urgently investigate and report on the wages situation including the wages structure in the baking industry. As the Board have only recently reported on costs and prices in the industry (Cmnd. 2760), the Government are asking the Board to consider making an interim report before the end of the year on this wage claim without prejudice to their ultimate findings.

3. The Board are accordingly requested to put in hand these inquiries.
