MINISTRY OF DEFENCE

The QUEEN has been graciously pleased on the advice of Her Majesty's New Zealand Ministers, to approve the undermentioned award in recognition of gallant conduct in the Borneo Territories:

Military Cross

Captain John MASTERS (071598), Royal New Zealand Artillery, seconded to 4th Light Regiment, Royal Artillery.

On 2nd September 1965, Captain Masters was acting as the Artillery Forward Observation Officer with a patrol of Support Company of 2/2nd Gurkha Rifles lying in ambush on one of the border rivers in the First Division of Sarawak.

The ambush party was attacked and forced to withdraw by an enemy force of about one hundred strong. During the initial engagement which consisted of an intense fire fight with the enemy force infiltrating towards and around the 2/2 G.R. party, Captain Masters, with the Gurkha C.S.M., was manning the check point for the withdrawal. Having seen all his ambush party withdraw under constant pressure from the enemy, Captain Masters and the C.S.M. left the check point position together under fire to join the remainder of the patrol in the pre-arranged RV. Almost at once the C.S.M. fell wounded in the leg by a burst of fire from the enemy, who were now closing fast. Captain Masters, seeing the C.S.M. fall and the enemy closing through the jungle, fired a few rounds at the enemy and went to the assistance of the wounded C.S.M. In doing this he clearly and consciously risked his own life in what can only be described as an extremely dangerous situation, to save the life of the C.S.M. Captain Masters comforted and protected the C.S.M. while the enemy were engaged by nearby members of Support Company. He then carried the wounded C.S.M. along what he thought to be the withdrawal route, but, owing to the density of the jungle and the continuous enemy fire, he became completely separated from the Support Company patrol which had to continue to withdraw.

For the remainder of the day Captain Masters carried the wounded C.S.M. through about 6,000 yards of very thick jungle and thigh-deep swamp in the intense heat of the day and by last light was completely exhausted. During the night he tended to the C.S.M.'s wounds and comforted him as best he could.

In the morning, as he was now weak and exhausted from the efforts of the previous day, Captain Masters wisely appreciated that he stood a much better chance of saving both their lives if he continued alone to the Security Forces base and returned with help for the wounded C.S.M. He therefore assured the C.S.M.

that he would return with help and left him hidden in the jungle with all the food and water they had remaining.

Captain Masters then walked through extremely difficult thick jungle and swamp by compass with incredible speed and eventually reached the base in the late afternoon. Even in an extremely exhausted state he immediately led a large search party back through the swamp to the wounded C.S.M.

Throughout the whole operation Captain Masters acted with great courage, determination and coolness and with complete disregard for his own safety. It would have been infinitely easier for him to continue running to the RV when the C.S.M. was hit, but in the face of heavy fire he chose to risk his own life and what must have seemed certain death or capture to save the life of a comrade.
