## WAITING RESTRICTIONS

*London Borough of Wandsworth*

The Greater London Council are about to consider a proposal that they should make an Order under section 10 of the London Government Act 1963 to impose restrictions on waiting by vehicles between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in:

Hyde Lane, London S.W.11.

(a) the north-west side, from a point opposite the south-western boundary of No. 39 Hyde Lane north-eastwards for a distance of 110 feet;

(b) the south-east side, between the south-western kerb line of Winstead Street and the south-western kerb-line of Battersea Bridge Road.

The restrictions would also apply to the first 45 feet of both sides of Randall Street and Winstead Street measured from their junctions with Hyde Lane.

Exemptions would be provided in the Order to permit vehicles to wait in order to pick up and set down passengers, to load and unload goods for limited periods, to carry out essential services or when used by local authorities in pursuance of statutory powers or duties.
