For unloading a blazing Army Vehicle which had crashed into an electric light pylon, in a built up area in Aden. The truck was carrying arms, radios, ammunition and phosphorous grenades. 2/Lieutenant McLeod with complete disregard for his own safety started unloading the truck and all the arms, radios and much of the ammunition were saved. By his courage and complete disregard for his own safety he was responsible for saving much valuable military equipment and stores and greatly lessened the danger to the local population, and to the Fire Brigade at the scene of the accident.

23952024 Private Michael Leslie Slaney, Royal Army Medical Corps.

Whilst returning to Dhala in the Western Aden Protectorate on completion of a long patrol in the mountains, the long in which Private Slaney and a number of his comrades were travelling in convoy ran over and exploded an anti-tank mine. The vehicle was seriously damaged and eight soldiers were injured. Some small arms fire was directed at the halted convoy.

In spite of being dazed by the explosion and despite the exchange of small arms fire Private Slaney im-mediately attended to the casualties, and only when a Royal Navy Helicopter and Medical Officer arrived would he allow himself to be given medical attention.
