SOUTHERN RHODESIA

The Southern Rhodesia (Prohibited Exports) (Chrome) Order 1966

*Made - - - - - 20th January 1966
Coming into Operation 20th January 1966
Laid before Parliament 20th January 1966*

I, Arthur George Bottomley, one of Her Majesty's Principal Secretaries of State, in exercise of the powers conferred on me by Article 3(2) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966 (S.I. 1966/41), hereby make the following Order:

1. This Order may be cited as the Southern Rhodesia (Prohibited Exports) (Chrome) Order 1966 and shall come into operation forthwith.

2. Chrome is hereby specified for the purposes of Article 1(1) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966.

3. In this Order "chrome" means chromium ore (chromite or chrome iron ore) and concentrates and ferro-chrome.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order specifies chrome for the purposes of Article 1(1) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966. This has the result of prohibiting the exportation of chrome from Southern Rhodesia and certain ancillary transactions except so far as may be authorised by regulations of the Secretary of State.
