SCOTTISH TEACHERS' SALARIES

The salaries of teachers in Scotland (other than University teachers) are determined separately from those of teachers in England and Wales, and the structure of both salaries and qualifications is different. At present negotiations for the two groups of teachers are not simultaneous, but fall in alternate years.

The salaries of Scottish teachers are to be increased by 13 per cent. from 1st April 1966. The Board is requested to examine whether on an overall comparison this percentage increase will put Scottish teachers generally into a fair relationship with teachers

in England and Wales, who were given an average percentage increase of 13 from 1st April 1965; and, if not, whether any further adjustment to this figure would be justified. Both settlements are to last for periods of two years.

The Board is also requested to recommend what arrangements should be made to ensure that in future salary changes for the two groups of teachers are considered at the same time in order to maintain an appropriate relationship between them.

HIGHWAYS ACT 1959

The Fishguard—Aberystwyth—Dolgelley—Caernarvon—Bangor (Menai Suspension Bridge) Trunk Road (Bronaber—Capel Jerusalem, Trawsfynydd Improvement Side Roads) Order 1966.

The Secretary of State hereby gives notice that in relation to the above-mentioned trunk road at Trawsfynydd in the county of Merioneth, he has made an Order under section 9 of the above Act the effect of which will—

(a) authorise the Secretary of State—

(i) to carry out improvements to Bronaber—Pen-y-Stryd Road and North of Byrdir—Pont-y-Gribble Road,

(ii) to stop up part of the Bronaber—Pen-y-Stryd Road, and

(iii) to construct a new highway to connect the Bronaber—Pen-y-Stryd Road with the Trunk Road, all at Trawsfynydd aforesaid, and

(b) provide for the transfer of the said new highway to the County Council of Merioneth as from the date on which the Secretary of State notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the Order and of the relevant plan have been deposited at the Welsh Office, Cathays Park, Cardiff, where they are open to inspection free of charge at all reasonable hours. Certified copies have also been deposited at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, and the offices of the County Council of Merioneth, County Offices, Penarlag, Dolgelley, where they are similarly open to inspection.
