PUBLIC HEALTH ACTS AND CLEAN AIR ACT

ST. HELENS COUNTY BOROUGH COUNCIL The St. Helens No. 2 Smoke Control Order, 1966

Notice is hereby given that the Mayor, Aldermen and Burgesses of the Borough of St. Helens acting by the Council in exercise of the powers conferred upon them by section 11 of the Clean Air Act, 1956, on the 31st day of January 1966 made an Order entitled "The St. Helens No. 2 Smoke Control Order, 1966," declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st day of December 1966, or before a later date determined by the Minister of Housing and Local Government.
