

Street from a point 22 yards south of Queen Street to the junction with High Street is already subject to one-way traffic working), (ii) from south-west to north-east in Maiden Street;

(b) to prohibit waiting at all times in The Strand, Castle Street, North Walk, Boutport Street (between North Walk and Pilton Causeway) and Pilton Causeway (where waiting is at present prohibited between 9 a.m.-5 p.m. on weekdays) and in South Street (between Newport Road and Rumsam Road);

(c) to prohibit waiting on weekdays in Queen Street and in a section of Litchdon Street (north-east side, between Barbican Road and New Road);

(d) to prohibit waiting between 9 a.m.-6 p.m. on weekdays in Trinity Street, Gammon Lane and Maiden Street and in sections of Barbican Road (between Trinity Street and Litchdon Street), Alexandra Road (between Bear Street and Oakleigh Road) and Boutport Street (Pilton Causeway to The Square);

(e) to extend other waiting restrictions (other than Trunk Road restrictions) which at present operate from 9 a.m.-5 p.m. on weekdays so that they shall operate from 9 a.m.-6 p.m. on weekdays. (Note: The roads affected are Bear Street, Butchers Row, Commercial Road, Coronation Street, Cross Street, Diamond Street, High Street, Joy Street, Silver Street, Tuly Street, Wells Street, Litchdon Street and The Square);

(f) to limit waiting to periods of 1 hour between 9 a.m.-6 p.m. on weekdays in Litchdon Street (section on south-west side, opposite the North Devon Infirmary);

(g) to prevent vehicles entering Holland Street direct from High Street.

A copy of the proposed Order and a plan can be inspected during usual office hours at The Castle, Barnstaple.

Exceptions from the waiting restrictions will be provided in the Order to permit boarding or alighting from vehicles; loading or unloading goods; building operations, road maintenance or other similar works; and to enable a vehicle to take in petrol, oil, water or air from a garage.
