TOWN AND COUNTRY PLANNING ACT 1962

The Secretary of State hereby gives notice that he proposes to make an Order under section 153 of the above Act to authorise the stopping up of two lengths of footpath and a footpath at Red Roofs Building Estate, Brynna Road, Pencoed, Glamorgan, in order to enable residential development to be carried out in accordance with planning permission granted to J. Evans (Barry) Ltd. by Cowbridge R.D.C.

The proposed Order will also require the provision of two new footpaths maintainable at the public expense, for which the highway authority is to be the Glamorgan C.C. and other new highways.

HIGHWAYS ACT 1959

The London—Fishguard Trunk Road (Carmarthen Diversion Side Road) Order 1966

The Secretary of State hereby gives notice that in relation to the above mentioned Trunk Road at Carmarthen in the County of Carmarthen he has made an Order under section 9 of the above Act, the effect of which is to authorise the Secretary of State to stop up a length of highway (a carriageway) at the junction of the Quay and Carmarthen Bridge.

Copies of the Order and of the relevant plan have been deposited at the Welsh Office, Cathays Park, Cardiff, where they are open to inspection free of charge at all reasonable hours. Certified copies have also been deposited at the Welsh Office, Roads Division, Graham Buildings, Newport Road, Cardiff, and at the offices of the County Council of Carmarthen, County Hall, Carmarthen, where they are similarly open to inspection.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may, within

six weeks from 18th February 1966, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

THE TRUNK ROAD (LLANGYNIDR SLIP ROAD (ONE-WAY TRAFFIC) ORDER 1966

THE TRUNK ROAD (LLANGYNIDR ROAD) (NO RIGHT-HAND TURN) ORDER 1966

Notice is hereby given that the Secretary of State proposes to make Orders under section 26 of the Road Traffic Act 1960, the effect of which will be that:

1. No person shall cause any vehicle to proceed in a direction other than from east to west along the Llangynidr Slip Road which extends from its junction with the southern carriageway of the Neath—Abergavenny Trunk Road (A.465) in a general westerly direction to its junction with the Beaufort—Llangynidr road (B.4560) in the Urban District of Ebbw Vale in the County of Monmouth.

2. No person shall cause any vehicle proceeding in a westerly direction in the Neath—Abergavenny Trunk Road (A.465) to make a right-hand turn into the Beaufort—Llangynidr road (B.4560).
