LONDON BOROUGH OF BARNET

London Borough of Barnet Smoke Control (No. 2) Order, 1965

Notice is hereby given that the Council of the London Borough of Barnet in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 2nd day of February 1966, made an Order entitled the London Borough of Barnet Smoke Control (No. 2) Order, 1965, declaring the area described in the Schedule below to be a smoke control area. The Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before the 1st October, 1967, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map to which it refers may be inspected free of charge at the Town Hall, The Burroughs, Hendon N.W.4, at all reasonable times during the period of six weeks from the 25th day of February 1966.

Within that period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.

SCHEDULE

Area bounded on the north by a line commencing at the Borough boundary with that of the London Borough of Harrow from the point of the crossing of High Street, Edgware, over the Edgware Brook and thence south-eastwards along the centre of the Edgware Brook to its point of junction with the Deans Brook, thence northwards along the centre of the Deans Brook to the point of its crossing by the disused London and North-Eastern Railway track, thence eastwards along the south side of the said track to the point of its crossing under the British Railways (Midland Region) line; on the east by a line southwards along the western side of the Midland Region line to the point of its crossing over the London Transport Northern line; on the south by a line north-westwards along the north side of the Northern line to the point of its crossing over Montrose Avenue, thence south-westwards along the centre of Montrose Avenue to a point in line in the centre of Burnt Oak Broadway and the Borough boundary, thence, north-westwards along the Borough boundary in the centre of Burnt Oak Broadway and High Street, Edgware, to the point of commencement.
