APPLICATION FOR LICENCE TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Great Ouse River Authority by The Carlton Tyre Saving Company Limited for a licence to abstract the following quantities of water from chalk underground strata at the following point of abstraction—Ordnance Survey Map reference TL 53 NW 5476 3805: A further 11,000 gallons per 24 hours at Shire Hill, Saffron Walden, Essex.

This water will be used in our existing system which abstracts water from one borehole, uses it in a circuit for cooling purposes, then eventually returns it absolutely clean and under favourable conditions at the same temperature as it was abstracted, to a second borehole approximately 212 feet from the first.
