Subject to the exemptions provided by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

THE GAS ACT 1948

EAST MIDLANDS GAS BOARD

The Gas (Declaration of Calorific Value) Regulations, 1949

and

The Gas (Declaration of Calorific Value) (Amendment) Regulations, 1951

STAVELEY

The East Midlands Gas Board hereby give notice that as from the 1st day of July 1966 they will supply gas from their Whittington Gasworks at Old Whittington, Chesterfield to those consumers in the Barrow Hill district of Staveley in the county of Derby occupying the premises referred to in the Schedule hereto which said premises are at present supplied by the East Midlands Gas Board with gas of a declared calorific value of 475 British Thermal Units per cubic foot. And the said Board in pursuance of the above Act and Regulations hereby declare that the calorific value of the gas to be supplied from their Whittington Gasworks aforesaid to those consumers on and after the 1st day of July 1966 will be 500 British Thermal Units per cubic foot.

NOTE. The declaration of calorific value as aforesaid will take effect for the purpose of calculating the charge to be made for gas supplied to any consumer immediately after the first reading of that consumer's meter after the 1st July 1966.
