- (4) The vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to any of the said lengths of road, or
- (5) Being a vehicle owned by a Funeral Director or owner of funeral vehicles when in use as part of a funeral cortege or otherwise in connection with a funeral.

Plans showing the locations and extent of the proposed Order are on deposit for inspection in the Engineer and Surveyor's Department, Council Offices, Westbury Manor, West Street, Fareham, during the usual office hours.

GLOUCESTERSHIRE COUNTY COUNCIL

The Gloucestershire County Council (Station Road, Yate) (Prohibition of Waiting) Order, 1966

Notice is hereby given that on the 23rd February 1966, the County Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is:

1. to prohibit the waiting of vehicles at all times in the length of road specified in the First Schedule to this notice ;
2. to prohibit the waiting of vehicles in the length of road specified in the first column of the Second Schedule to this notice :
 - (a) on the side of road specified opposite that length of road in the second column of the said Schedule on the days named therein, or
 - (b) on the side of road specified opposite that length of road in the third column of the said Schedule on the days named therein.

The Order, which comes into operation on 28th February 1966, will not prohibit vehicles from waiting for so long as is necessary (a) to enable a person to board or alight or to enable goods to be loaded or unloaded ; (b) to enable the vehicles to be used in connection with any building operation or demolition, highway or specified public utility operation.

GLOUCESTERSHIRE COUNTY COUNCIL

The Gloucestershire County Council (Broad Lane and Love Lane, Yate) (Restriction) Order, 1966

Notice is hereby given that the Gloucestershire County Council have applied to the Minister of Transport for confirmation of an Order made by them under section 26 of the Road Traffic Act, 1960, the effect of which will be to prohibit the driving of any vehicle the unladen weight of which exceeds three tons on either of the lengths of road specified in the Schedule hereto.
