BLACKPOOL COUNTY BOROUGH COUNCIL

The County Borough of Blackpool (Mellwood Avenue) (Prohibition of Through Traffic) Order, 1966

Notice is hereby given that the Council of the County Borough of Blackpool have applied to the Minister of Transport for confirmation of an Order made by them under subsections (1), (2) and (3) of section 26 of the Road Traffic Act, 1960, and of all other powers them enabling in that behalf the effect of which will be:

1. Save as provided in Article 2 of that Order no person shall drive or cause or permit to be driven any mechanically propelled vehicle:

(a) proceeding from any part of Mowbray Drive to any part of Carleton Avenue; or
(b) proceedings from any part of Carleton Avenue to any part of Mowbray Drive
along the road specified in the Schedule to that Order and set out below.

2. Nothing in Article 1 of that Order shall prevent the driving upon the road specified in the said Schedule of any vehicle which is being used:

(a) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that road; or
(b) in connection with any building operation or demolition in or adjacent to that road, the removal of any obstruction to traffic in that road, the maintenance, improvement, or reconstruction of that road, or the laying, erection, alteration or repair in or adjacent to that road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity, or of any telegraphic line as defined in the Telegraph Act 1878.

3. Objections to the Order must be sent to the Secretary, Ministry of Transport (RTC) at St. Christopher House, Southwark Street, London S.E.1, by Friday, the 1st day of April 1966, and a copy sent to the undersigned.
