SOUTHERN RHODESIA

*The Southern Rhodesia (Prohibited Exports)
(Iron Ore) Order 1966*

Made - - - - 7th April 1966

Coming into Operation 13th April 1966

To be laid before Parliament

I, Arthur George Bottomley, one of Her Majesty's Principal Secretaries of State, in exercise of the powers conferred on me by Article 3 (2) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966 (S.I. 1966/41 (1966 I, p. 64)), hereby make the following Order:

1. This Order may be cited as the Southern Rhodesia (Prohibited Exports) (Iron Ore) Order 1966 and shall come into operation on 13th April 1966.

2. Iron ore is hereby specified for the purposes of Article 1 (1) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966.

3. In this Order "iron ore" includes concentrates of iron ore, roasted iron pyrites and roasted cupreous iron pyrites.

EXPLANATORY NOTE

(This Note is not part of the Order.)

This Order specifies iron ore for the purposes of Article 1 (1) of the Southern Rhodesia (Prohibited Exports and Imports) Order 1966. This has the result of prohibiting the exportation of iron ore from Southern Rhodesia and certain ancillary transactions except so far as may be authorised by regulations of the Secretary of State.
