

of any fuel other than an authorised fuel. The authorised fuels include, anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Orders will not come into operation before the 1st day of September 1967, or such later date as may be determined by the Minister of Housing and Local Government.

Copies of the Orders and of the maps referred to therein may be inspected free of charge at the Council House, Poplar Road, Solihull, at all reasonable times during the period of 6 weeks from the 3rd day of June 1966.

Within the said period, any person who will be affected by the Orders may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Orders.
