### NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT, 1949

#### Anglesey Areas of Outstanding Natural Beauty (Designation) Order, 196

Notice is hereby given that the National Parks Commission propose to make and submit to the Secretary of State for Wales for confirmation the above Order.

2. The effect of the proposed Order which will not come into operation until confirmed by the Secretary of State for Wales will be to constitute the land to which the proposed Order relates an area of outstanding natural beauty for the purposes of the National Parks and Access to the Countryside Act 1949.

3. The proposed Order relates to land situated in the County of Anglesey and comprises land within the undermentioned districts:
