## CHESHIRE COUNTY COUNCIL

*The County of Chester (Witton Street and Chester Way, Northwich) (Prohibition of Waiting) Order, 1966.*

Notice is hereby given that on the 1st June 1966, the Cheshire County Council made an Order under section 26 of the Road Traffic Act, 1960, the effect of which is to prohibit waiting between the hours of 9 a.m. and 6 p.m. on Mondays to Saturdays inclusive, on the following lengths of road in Northwich, viz:

*Witton Street—*

*North Side*—from its junction with Timber Lane to its junction with Brook Street.

*South Side*—from its junction with Timber Lane to its junction with Chester Way.

*Chester Way*—from its junction with Witton Street for a distance of 100 feet in a southerly direction.

The Order, which will come into operation on the 20th June 1966, contains the usual exemptions to permit vehicles to wait for the purposes of loading or unloading goods, allowing persons to board or

alight, to enable works to be carried out or to take in petrol, oil, water or air from garages situate in the lengths of road concerned.
