PONTEFRACT BOROUGH COUNCIL

ROAD TRAFFIC ACT 1960

Traffic Regulation Orders

Notice is hereby given that on the 2nd day of June 1966, the Council of the Borough of Pontefract made the following Orders under sections 26 and 27 of the Road Traffic Act, 1960, to come into effect on the 20th day of June 1966; the effect of which will be, subject:

(a) as to the Borough of Pontefract (No. 1) Traffic Regulation (Prohibition of Waiting) Order, 1966, to exemptions to enable a vehicle to wait for so long as may be necessary for a person to board or alight from a vehicle and to enable goods to be loaded on to or unloaded from a vehicle, or to enable a vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of lengths of road or the services therein and to enable a vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the length of road described in that Order, and

(b) as to the Borough of Pontefract (Nos. 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13 and 14) Traffic Regulation (Prohibition of Waiting) Orders, 1966, to exemptions to enable a vehicle to wait for so long as may be necessary for a person to board or alight from a vehicle and to enable goods to be loaded on to or unloaded from a vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of lengths of road or the services therein,

to provide that no person, except with the permission of a Police Constable in uniform, shall cause or permit any vehicle to wait at any time throughout the year, in any of the lengths of road, brief particulars of which are set out below, that is to say:

1. *The Borough of Pontefract (No. 1) Traffic Regulation (Prohibition of Waiting) Order, 1966*

A.645 from the Priory (in Wakefield Road) to Gillygate with the exception of certain parts of the central reservation and the lay-by in front of the Pontefract General Infirmary.

This Order also revokes The County of the West Riding of Yorkshire (Traffic Regulation) (Pontefract) No. 4 Order 1953.

2. *The Borough of Pontefract (No. 2) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Mill Hill Road (A.639) (part).

3. *The Borough of Pontefract (No. 3) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Ropergate End, eastern side and Ropergate, south-eastern side.

4. *The Borough of Pontefract (No. 4) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Beastfair (A.639) north-eastern side.

5. *The Borough of Pontefract (No. 5) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Front Street (A.639) northern side (part) and Cornmarket (A.639) northern side (part).

6. *The Borough of Pontefract (No. 6) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Salter Row and Woolmarket (part).

7. *The Borough of Pontefract (No. 7) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Bridge Street (B.6210) and Woolmarket (part).

8. *The Borough of Pontefract (No. 8) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Trinity Street, north-eastern side.

9. *The Borough of Pontefract (No. 9) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Valley Road (A.639) with exception of lower section of central reservation.

10. *The Borough of Pontefract (No. 10) Traffic Regulation (Prohibition of Waiting) Order, 1966*

Gillygate, south-western side.

11. *The Borough of Pontefract (No. 11) Traffic Regulation (Prohibition of Waiting) Order, 1966*

South-eastern side of Bridge Street.

12. *The Borough of Pontefract (No. 12) Traffic Regulation (Prohibition of Waiting) Order, 1966*

North-eastern end of Market Place.

13. *The Borough of Pontefract (No. 13) Traffic Regulation (Prohibition of Waiting) Order, 1966*

North-western side of Ropergate from its junction with Beastfair for a distance of 180 feet in a south-westerly direction.

14. *The Borough of Pontefract (No. 14) Traffic Regulation (Prohibition of Waiting) Order, 1966*

South-eastern side of Market Place from its junction with Valley Road (A.639) for a distance of 30 feet in a north-easterly direction.
