

**SOMERSET COUNTY COUNCIL**

*The County of Somerset (Various Streets at Dunster) (Prohibition of Waiting) Order, 1966*

Notice is hereby given that on the 3rd day of June 1966, the County Council of Somerset made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is to prohibit, subject to the exceptions which are specified in the Order, the waiting of vehicles on the lengths of road specified in the Schedule to this notice between the hours of 8 a.m. and 7 p.m.

**SCHEDULE**

*Lengths of road upon which waiting is prohibited between the hours of 8 a.m. and 7 p.m.*

*Market Place and High Street (A.396) (East Side)* between the corner north of the Luttrell Arms Hotel and a point approximately 15 yards south of the Yarn or Butter Market.

*High Street, Dunster (A.396) (West Side)* between the junction with Church Street and a point 50 yards north of that junction.

*West Street, Dunster (A.396) (West Side)* between the junction with Church Street and a point opposite the south side of the junction with Mill Street.

The Order will come into operation on 13th June 1966.

**STRETFORD BOROUGH COUNCIL**

Notice is hereby given that on the 16th May 1966, the Stretford Borough Council made the under-mentioned Orders under sections 26 and 27 of the

Road Traffic Act, 1960, and that the Orders will come into operation on the 1st July 1966:

(a) *The Borough of Stretford (Moss Road and Station Road) (Prohibition of Waiting) Order, 1966*

The effect of this Order is to prohibit the waiting of vehicles (subject to the normal exceptions) on Station Road and on Moss Road from Station Road for a distance of 267 linear yards in a northerly direction.

(b) *The Borough of Stretford (Victoria Road East Side) (Prohibition of Waiting) Order, 1966*

The effect of this Order is to prohibit the waiting of vehicles (subject to the normal exceptions) on the east side of Victoria Road.

(c) *The Borough of Stretford (Great Stone Road—Quadrant to Talbot Road) (Prohibition of Waiting) Order, 1966.*

The effect of this Order is to prohibit the waiting of vehicles (subject to the normal exceptions) on the length of Great Stone Road from the Quadrant to Talbot Road between the hours of 8 a.m. and 11.30 p.m.

(d) *The Borough of Stretford (Trafford Park Road, Ashburton Road and Westinghouse Road) (Prohibition of Waiting) (Amendment) Order, 1966.*

The effect of this Order is to amend The Borough of Stretford (Trafford Park Road, Ashburton Road and Westinghouse Road) (Prohibition of Waiting) Order, 1962, by extending the afternoon/evening prohibition on waiting and on loading and unloading goods—at present operating between 4 p.m. and 6 p.m. from Monday to Friday inclusive—so that its time of commencement will be 3 p.m.

**TYNEMOUTH COUNTY BOROUGH COUNCIL**

*The County Borough of Tynemouth (Sea Front) (Prohibition of Waiting) Order, 1966*

Notice is hereby given that the Tynemouth County Borough Council propose to make an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which (with certain exceptions) will be to prohibit the waiting of all vehicles on the lengths of road specified in the Schedule hereto.

The exceptions referred to will enable a vehicle to wait for as long as may be necessary to enable a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, to enable the vehicle to take in petrol, oil, water or air from any garage, or to enable the vehicle to be used in connection with any funeral, building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

Objections to the proposals must be sent in writing to the undersigned by the 4th July 1966.

| 6. Grand Parade from its junction with Hotspur Street to a point approximately 100 yards north of its junction with Percy Park.  | West.                    |
| 7. Grand Parade from its junction with Beach Road for a distance southwards of 50 yards.   | West.                    |
| 8. Beach Road from its junction with Grand Parade to a point 50 yards west of the railway bridge.  | Both.                    |
| 9. Mast Lane, Cullercoats, from its junction with Grand Parade to its junction with the back lane at the rear of Beverley Terrace.   | Both.                    |
| 10. Victoria Crescent and Front Street, Cullercoats, from the junction of Victoria Crescent with Beverley Terrace to the junction of Front Street with Promontory Terrace.   | Both.                    |
