Court—HIGH COURT OF JUSTICE. No. of Matter—191 of 1962. Date of Order—12th May, 1966. Nature of Order made—Bankrupt's discharge suspended for six months, and that he be discharged as from 12th November, 1966, subject to the following condition as to his future earnings, income and after acquired property, namely the bankrupt shall pay to the Official Receiver as Trustee a sum of not less than £4 (four pounds) per week until a further sum of £200 (two hundred pounds) is in the hands of the Trustee for the benefit of the bankrupt's estate.
