### HONOURS AND AWARDS

#### CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD

St. James's Palace, London S.W.1.

12th July 1966.

The QUEEN has been graciously pleased, on the advice of Her Majesty's New Zealand Ministers, to approve the award of the George Medal to the under-mentioned:

(To be dated 24th June 1966)

Anthony Eric JOHNS of Bell Block, New Plymouth.

On the 8th of January 1966, Anthony Johns was surf-board riding some 75 to 100 yards off shore at Oakura Beach, Taranaki, when he saw a girl bather about 20 yards from him attacked by a shark. With complete disregard for his own safety he went at once to her assistance. Although the shark collided with his surf board just before he reached her, he succeeded in getting the girl on to the board and in taking her ashore.

Two doctors attempted to give the girl emergency treatment as soon as she reached the beach, but their opinion was that she was dead when she arrived ashore through loss of blood.

#### ARCHITECTS REGISTRATION COUNCIL OF THE UNITED KINGDOM

REGULATIONS MADE IN PURSUANCE OF SECTION 13 OF  
THE ARCHITECTS (REGISTRATION) ACT, 1931,  
AMENDING THE EXISTING REGULATIONS.

1. In Regulation 37 (a) delete the words "one pound and ten shillings" and substitute therefor the words "three pounds".

2. In Regulation 37 (b) (i) delete the words "three pounds" and substitute therefor the words "six pounds".
