PRIVY COUNCIL OFFICE

At the Court at Buckingham Palace, the 28th day of July 1966.

Present,

The Queen's Most Excellent Majesty in Council Whereas by section 3 of the Naval and Marine Pay and Pensions Act 1865 (28 & 29 Vict. c. 73.) it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof, payable in respect of services in Her Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall be paid in such manner and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to amend the Order concerning pensions and other grants in cases where the disablement or death of members of the naval forces is due to service during the 1914 World War and after 2nd September 1939:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

The Order in Council dated 25th September 1964, as amended (There is no amendment which relates as amended to the subject matter of this Order) relating

The Order in Council dated 25th September 1964, as amended (There is no amendment which relates expressly to the subject matter of this Order.), relating to members of the naval forces as therein defined (hereinafter referred to as "the 1964 Order") shall be amended in the respects set out in the following provisions of this Order.

Higher maximum rate of allowance for part-time treatment

1. In Schedule 6 to the 1964 Order, for paragraph 10 (part-time treatment allowance under Article 23) there shall be substituted the paragraph set out in the Appendix hereto.

Commencement

This Order shall come into operation on 1st August 1966.

APPENDIX

Paragraph to be substituted in Schedule 6 to the 1964 Order

"10. Part-time treatment allowance under Article 23—65s. per day (maximum); 65s. per day (maximum)".

EXPLANATORY NOTE

This Order further amends the Order of 25th September 1964 by increasing the maximum rate of the allowance payable to certain persons having

regard to any remunerative time lost as a result of receiving part-time treatment for their pensioned disablement.

The Merchant Shipping (Safety Convention Countries) (Various) (No. 2) Order 1966

Present,

The QUEEN'S Most Excellent Majesty in Council Whereas by section 31 of the Merchant Shipping (Safety Convention) Act 1949 (1949 c. 43.) as amended by section 1 of the Merchant Shipping Act 1964 (1964 c. 47.) it is enacted that Her Majesty, if satisfied that the government of any country has accepted the International Convention for the Safety of Life at Sea 1960 (hereinafter referred to as "the 1960 Convention"), may by Order in Council make a declaration to that effect:

And Whereas Her Majesty is satisfied that the governments of the countries specified in the Schedule to this Order have accepted the 1960 Convention:

Now, therefore, Her Majesty, in pursuance of the powers conferred upon Her by the aforesaid sections and of all other powers enabling Her in that behalf, by and with the advice of Her Privy Council, is pleased to order, and doth hereby order, as follows:—

- 1. It is hereby declared that the governments of the countries specified in the Schedule to this Order have accepted the 1960 Convention.
- 2. This Order may be cited as the Merchant Shipping (Safety Convention Countries) (Various) (No. 2) Order 1966, and shall come into operation on 8th August 1966.
