23991400 Trooper Leslie Bernard WILSON
4th/7th Royal Dragoon Guards.

On the night of 26th May 1966, Dhala Camp, Aden, was attacked by a large force of heavily armed dissidents. Trooper Wilson immediately mounted his armoured car, and reported to the Defence Commander that he was ready to engage the enemy. Acting on orders he quickly and accurately brought down fire from his main armament which immediately silenced the enemy.

Trooper Wilson completed the whole action both as Commander and Gunner without the assistance of his crew who had been pinned down by the intensity of the enemy fire.

His abundant confidence and calm, the speed and accuracy with which he fired the 76 m.m. gun was an inspiration to all, and there is no doubt that he played a major part in repelling the enemy attack.
