HER Majesty having granted a Commission under the Great Seal for Passing the Royal Assent to those Bills which have been agreed to by both Houses of Parliament, the Lords commission'd accordingly pass'd the Royal Assent to the several publick and private Bills following:

An Act for raising a further Supply to Her Majesty, for the Service of the Year 1708, and other Uses, by Sale of Annuities, charged on a Fund not exceeding Forty Thousand Pounds per Annum, to arise by appropriating several Surplusses, and by granting further Terms in the Duties on Law-Wines, and on Brewers, Pedlars, and Petty Chapman, the Stamp Duties, the One Third Subsidy, the Duty on Sweets, and One of the Branches of Excise; and by making other Provision in this Act mention'd.

An Act for the Security of Her Majesty's Person and Government, and of the Succession to the Crown of Great Britain in the Protestant Line.

An Act for rendering the Union of the Two Kingdoms more entire and complear.

An Act for Repairing, Amending and Enlarging, the Highway between the Top of Kingidown Hill and the City of Bath; and also several other Highways leading to and through the said City; and for Cleansing, Paving, and Lightening the Streets, and regulating the Chairmen there.

An Act for vesting in Ralph Freeman the Younger, Esq; and his Heirs, divers Manors and Lands in the County of Essex, compris'd in his Marriage Settlement, he having settled other Manors and Lands in the County of Hertford, of greater Value, in like Use, in lieu thereof.

An Act for Naturalizing Katherine Clerke, Daughter of William Clerke Bar. deceased.

An Act for Naturalizing Marcos Dos Santos.

An Act for making good to William Thompson Esq; the Benefit intended to be granted to his Ancestors, and their Heirs, by certain Letters Patents of King Charles the Second, in lieu of the Castle of Scarborough, and other Things by them surrendr'd to and now enjoy'd by the Crown.

Within half an Hour after the Act for the Supply by Sale of Annuities was pass'd, the whole Fund was fill'd.

Lusbon, Febr. 7. N. S. The Forces of his Portugese Majesty are put into a most exact and regular Disposition. The Horse and Dragoons are reduc'd into 11. Regiments; each Regiment to be compos'd of 480 Men. The Foot are divid'd into 30. Regiments; each consisting of 600 Men. And proper Methods are taken for the Monthly Payment of the whole Army.

Vienna, Febr. 4. All the Letters from the Upper Rhine agree in Advice, That the French have dispatch'd Letters through all the Circle of Swabia, wherein they require the several Princes and States to bring in their Contributions within the Time appointed, upon Pain of Military Execution. They demand of the Duke of Wirtemberg Two Millions, one of which was to have been paid on the 16th of January last, and the other on the first of this Instant February. Our last Letters from Milan are so circumstantial in the Report of the Surrender of Sardinia, as to say, they have Advice, That upon the Arrival of the Confederate Fleet before that Island, 100 Soldiers retir'd to a certain Castle, but were oblig'd by some Troops which landed to declare for his Catholick Majesty: After which the Allies left a sufficient Force to protect the Kingdom, and pursued their Voyage to Barcelona. The Hungarian Parties which lately pass'd the Waag have retir'd over that River upon the Approach of some Imperial Detachments. Several of their Men who straggled from their main Body are kill'd and taken Prisoners. Count Wackerbart is arriv'd here from King Augustus, in order to take, in his Majesty's Name, the Investiture of the Fiefs which that Prince holds of the Empire. We have certain Advices, That the late Motions of the French in Alfatia were grounded on a Conspiracy they had form'd for surprizing the Town of Fribourg. They had been in Treaty for some Weeks with the Lieutenant-Colonel, a Captain, and an Ensign, of the Swiss Regiment of Eulath; to whom they had promis'd a Reward of 100000 Livres, in case they should deliver into their Hands within a certain Time the middle Castle of that Place; but the Officers communicated to the Governor what had been propos'd by the Enemy. The Governor transmitted an Account of this Affair to General Thungen, who order'd the Officers to proceed in the Treaty, and promise the Surrender of the Castle between 3 and 4 of the Clock in the Morning of the 22d of January last past. The Officers acted accordingly, and the French gave 'em to understand, That at the Time propos'd there should appear 1000 Grenadiers to take possession of the Castle, who should, the same Day, be follow'd by 20 Battalions of Foot, and as many Squadrons of Horse,

**Hops**, with some Pieces of Cannon; by which Force it was intended to prevent the Governor's retiring with his Garrison. There was equal Care taken by the Governor to receive 'em at their Approach with Cannon, Musket-shots, and Hand-Grenadoes: But the Enemy having receiv'd Intelligence on their March of these Preparations, return'd back into their Quarters. The Officers who were to have betray'd the Place had an Obligation sign'd by the Marshal Villars, and the Sieur Pelletier de la Houffaise Intendant of Alsatia, for the Payment of the 10000 Livres: Upon Sight of which Original Instrument, General Thungen rewarded their Fidelity with the same Sum with which the Enemy attempted to corrupt it.

**Berne, Febr. 11. N. S.** The Diet of Baden have employ'd their Time with much Diligence in forming several Projects of a Neutrality for Neuchâtel. The Roman-Catholick Cantons have attempted to limit it in such a manner as to have Respect to the French Pretenders; but the Protestants have insisted upon a simple and absolute Neutrality without any Restrictions whatsoever, according to their first Instructions. This Constancy in the Protestants has oblig'd the Roman-Catholicks to content themselves with a Matter Reserve, and leave the Right of each Pretender as a Matter not before them; insinuating only on a Neutrality for that Country at present, till the Repose of it is better secur'd by a general Peace. The Diet have hereupon unanimously made a Representation to the French Ambassiator for such a Neutrality; to which that Minister seems to incline, provided they will give him the necessary Securities for the Observance of it on the Part of the King of Prussia. However this Representation is not wholly approv'd here, because they seem'd to ask the Neutrality as a Matter of Grace and Favour; whereas they ought to have demanded it as a Right grounded upon the perpetual Alliance with France, and the Treaty of Neutrality made in 1702, by which Neuchâtel is acknowledg'd part of Swisserland, and entitl'd to all its Rights and Privileges. The British Envoy presented a Memorial to this Canton on this Occasion, to animate their Resolutions; with an Assurance of Her Majesty's Assistance in case Neuchâtel should be attack'd; and the Canton Yesterday sent new Directions to their Deputies absolutely to insist upon the Acknowledgment of Neuchâtel as part of Swisserland, and to assert its Title to the Neutrality which the rest of the Helvetic Body enjoys by Virtue of the perpetual Alliance with France renew'd in 1663, and of the Treaty made in 1702. They have added to these Orders an Instruction to require the same Security against any Invasion of Neuchâtel from France, which the French Ambassador demands against any Invasion of Franche Comté from Neuchâtel; and to demand a Reciprocation of Conditions in all other Points. They have allow'd their Deputies no Latitude to swerve from the strict Letter of these Orders; but have commanded 'em to return home, if the French Minister will not act upon this Foundation.

**Kensington, Febr. 15.** Her Majesty has been pleas'd to make Choice of the Rt. Hon. *Henry Boyle* Esq; to succeed *Mr. Harley* in the Office of One of Her Majesty's Principal Secretaries of State; who this Evening in Council had the usual Oath of Secretary of State administr'd unto him, and took his Place at the Board accordingly.

**Whitehall, Febr. 13.** On Sunday last Sir William Dawes Bar. was consecrated to the Bishoprick of Chester by his Grace the Lord Archbishop of York, in the Abbey of Westminster.
