Reference to the National Board for Prices and Incomes

Pay of Ancillary Workers in the National Health Service

The current three year pay agreement for about 250,000 workers covered by the Ancillary Staffs Whitley Council for the Health Services expires at the end of October 1966. The last pay increase was of 7s. a week from November 1965, and in addition a reduction in the normal working week from 42 to 40 hours without loss of pay took effect from February 1066 1966.

1966. 2. A claim for a 22s. a week increase has recently been submitted on behalf of these workers. It is understood that a smaller basic increase would be acceptable if a structural review, giving a further element of betterment, were undertaken, and that a larger increase would be required if efficiency and productivity measures were to be negotiated. 3. The pay of ancillary workers in the National Health Service has in the past been closely related to that of manual workers employed by local authorities, as well as that of manual workers in the electricity, gas and water supply industries.

#### Pay of Manual Workers in the Gas Industry

Agreement has recently been reached for an increase of 3<sup>1</sup>/<sub>2</sub>d. an hour for 75,000 manual workers in the gas supply industry, from the 3rd July 1966. The last increase was of 4d. an hour effective from June 1965, and in addition, a reduction in the normal working week from 42 to 40 hours without loss of pay took effect from September 1965. 2. ### Reference to the National Board for Prices and Incomes

Pay of Manual Workers in the Water Supply Industry Agreement has recently been reached and implemented for an increase of  $3\frac{1}{2}d$ . an hour for about 26,000 manual workers in the water supply industry in England and Wales, effective from the first full pay week after 10th April 1966. This followed an increase of  $5\frac{1}{2}d$ . an hour, part of which was to offset a reduction in the normal working week from 42 to 40 hours effective from 3rd October 1965, and an increase of  $2\frac{1}{2}d$ . an hour effective from 11th April 1965.

In view of these relationships and the importance of each of these industries in the national economy, and the fact that the question of the "staff status" agreement in the electricity supply industry has been referred for examination by the National Board for Prices and Incomes as part of a general examination of productivity agreements, the Government consider it desirable that the National Board for Prices and Incomes should examine the pay and conditions of service of manual workers in the water supply industry and the principles for determining these, concurrently with the examination of the other groups mentioned.

Accordingly, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act, 1966, the First Secretary of State and the Minister of Housing and Local Government hereby refer to the National Board for Prices and Incomes for examination the question of the pay and conditions of service, and the principles for determining these, of manual workers in the water supply industry.

## Reference to the National Board for Prices and Incomes

#### Pay of Manual Workers in Local Authorities

A two-year pay agreement was reached recently for about 450,000 workers covered by the National Joint Council for Local Authorities Services (Manual Workers). This provides for general increases for fulltime adult male workers of about 11s. 8d. a week effective from 5th September 1966, and 10s. a week effective from 4th September 1967. The last general pay increase was of 7s. a week for men, effective from 6th September 1965, and in addition a reduction in the normal working week from 42 to 40 hours without loss of pay took effect from January 1966.

2. The pay of certain manual workers in the local authorities' services has in the past been closely related to that of similar manual workers employed in the electricity, gas and water supply industries as well as that of ancillary workers in the National Health Service.

3. The pay of some County Council road-men (about 30,000) follows closely the pay of road-men employed in other local authorities although it is separately negotiated; for both groups, the last pay increase and the reduction in hours were similar. No new pay agreement has, however, yet been negotiated for County Council road-men.

4. In view of these relationships and of the importance of these services in the national economy, the fact that the question of the productivity agreements in the electricity supply industry, introduced in 1964-65, has been referred for examination by the National Board for Prices and Incomes as part of a general examination of productivity agreements, and the difficulty of assessing productivity in non-trading services, the Government consider it desirable that the National Board for Prices and Incomes should examine the pay and conditions of service of manual workers in local authorities' services, including County Council road-men, and report on the principles for determining these, concurrently with its examination of the other groups mentioned.

Accordingly, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act, 1966, the First Secretary of State and the Minister of Housing and Local Government hereby refer to the National Board for Prices and Incomes for examination the question of the pay and conditions of service, and the principles for determining these, of manual workers in local authorities' services in England and Wales.
