- (ii) Stoneleigh Park Road, Ewell, between its junction with Kingston Road and a point 45 ft. north-east of that junction, and

(iii) West Street, Ewell, between its junction with High Street and a point opposite the boundary of Nos. 48 and 50 West Street. The Order shall come into operation on the 14th
