between the hours of 8 a.m. and 7 p.m. in any of the lengths of road specified in the First Schedule to this notice;

between the hours of 8 a.m. and 7 p.m. for a longer period than 45 minutes in any two hours in the lengths of road specified in the Second Schedule to this notice.

Exceptions are made in the Order to enable a vehicle to wait for as long as may be necessary:

(a) to enable a person to board or alight from a

vehicle;

(b) to enable goods to be loaded or unloaded; (c) in connection with the execution of works specified in the Order;
(d) in connection with a funeral.

The Order will come into effect on 14th September 1966.
