EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY

DURHAM COUNTY COUNCIL

Urban District of Houghton-le-Spring

Notice is hereby given that the Minister of Housing and Local Government in exercise of his powers under section 155 of the Town and Country Planning Act 1962, proposes to make an Order extinguishing the public rights of way over:

- (i) part of Hopper Street being the part which starts at its junction with Back Newbottle Street and runs south-west for a distance of approximately 65 feet,
- (ii) part of Back Hopper/Robinson Street being the part which starts at a point 65 feet north-east of its junction with Newbottle Street and runs north-east for a distance of approximately 105 feet,
- (iii) part of Robinson Street being the part which runs generally north-east for a distance of approximately 194 feet from Newbottle Street to Back Bowlby Street (East),
- (iv) the whole of Back Bowlby Street (East) including two unnamed junctions running south-west from Back Bowlby Street (East) to Bowlby Street and adjacent to Nos. 15 and 57 Bowlby Street respectively,
- (v) the whole of Bowlby Street,
- (vi) the whole of Back Bowlby Street (West) including a small cul-de-sac running south-west off Back Bowlby Street (West) at a point 62 feet north-west of the junction of Back Bowlby Street (West) with Mautland Street,
- (vii) part of Mautland Street being the part which runs north-east for a distance of approximately 146 feet from Back Bowlby Street (West) to Back Bowlby Street (East),
- (viii) part of Back Mautland Street (South) being the part which starts at its junction with Back Bowlby Street (East) and runs north-east for a distance of approximately 19 feet,
- (ix) part of Back Sunderland Street being the part which starts at its junction with Back Bowlby Street (East) and runs north-east for a distance of approximately 42 feet and
