## MINISTRY OF DEFENCE

The QUEEN has been graciously pleased to give orders for the publication of the name shown below as having received an expression of Commendation for brave Conduct:

22786918 Sergeant John Tenant GALL, Royal Regiment of Artillery.

On the 28th April 1966, at Monks Field in the Radfan, during an attack by tribesmen a bazooka round landed in one of the gun pits, the explosion killed the sergeant in charge of the gun and two members of the gun detachment and wounding four others. In addition an ammunition bay caught fire and there was the further danger of an explosion.

Sergeant Gall ignoring the danger from blazing ammunition, and despite heavy enemy small arms fire, helped to carry out the body of one of the gunners.

He then led a successful attempt to put out the fire, and then returned to the remaining gun, and controlled the continuing engagement of the enemy until the attack was beaten off.

In a dangerous situation Sergeant Gall's leadership and determination inspired all members of the section.
