Land Drainage Act, 1930

*Burgh-by-Sands, Beaumont and Orton Drainage
District*

Notice is hereby given that the Minister of Agriculture, Fisheries and Food, in exercise of the powers conferred upon him by sections 4 (3) and 14 of the Land Drainage Act, 1930, as applied by the Water Resources Act, 1963, proposes to make an Order confirming a Scheme submitted to him by the Cumberland River Authority, under section 4 (1) (b) of the Land Drainage Act, 1930, making provision for the alteration of the boundaries of the Burgh-by-Sands, Beaumont and Orton Drainage District.
