#### UNION OF BENEFICES MEASURES 1923 TO 1952

The Scheme also provides for the taking down and the sale of the site and materials of the church of Saint Maurice, York.

#### TOWN AND COUNTRY PLANNING ACT 1962

The Secretary of State hereby gives notice that he has made an Order under section 153 of the above Act entitled "The Diversion of Highways (County of Glamorgan) (No. 10) Order 1966" authorising the diversion of a length of footpath across Ponty-gwindy Farm, Caerphilly, and involving the provision of a new footpath.
