

Newcomen Road

- (a) Between a point 30 ft. west of the west side of Twyford Avenue and a point 30 ft. east of the east side of Twyford Avenue.
- (b) Between its junction with the west side of Stamshaw Road and a point 30 ft. west of that junction.

Winstanley Road

- (a) Between a point 30 ft. west of the west side of Twyford Avenue and a point 30 ft. east of the east side of Twyford Avenue.
- (b) Between its junction with the west side of Stamshaw Road and a point 30 ft. west of that junction.

Meyrick Road

- (a) Between a point 30 ft. west of the west side of Twyford Avenue and a point 30 ft. east of the east side of Twyford Avenue.
- (b) Between its junction with the west side of Stamshaw Road and a point 30 ft. west of that junction.

Knox Road

- (a) Between a point 30 ft. west of the west side of Twyford Avenue and a point 30 ft. east of the east side of Twyford Avenue.
- (b) Between its junction with the west side of Stamshaw Road and a point 30 ft. west of that junction.

Ranelagh Road. Between its junction with the west side of Twyford Avenue and a point 30 ft. west of that junction.

St. Mark's Road

- (a) Between its junction with the east side of Twyford Avenue and a point 30 ft. east of that junction.
- (b) Between its junction with the west side of Stamshaw Road and a point 30 ft. west of that junction.

Lower Derby Road

- (a) Between a point 30 ft. west of the west side of Twyford Avenue and a point 30 ft. east of the east side of Twyford Avenue.
- (b) Between its junction with the west side of Stamshaw Road and a point 30 ft. west of that junction.

Stanley Road. Between its junction with the west side of Twyford Avenue and a point 30 ft. west of that junction.

Simpson Road. Between its junction with the west side of Twyford Avenue and a point 30 ft. west of that junction.

London Avenue. Between its junction with the east side of Stamshaw Road and a point 30 ft. east of that junction.

Weymouth Road. Between its junction with the east side of Stamshaw Road and a point 30 ft. east of that junction.

Angerstein Road. The north side between its junction with the east side of Stamshaw Road and a point 30 ft. east of that junction.

Derby Road. Between its junction with the east side of Stamshaw Road and a point 30 ft. east of that junction.

Pitcroft Road. Between its junction with the east side of Stamshaw Road and a point 30 ft. east of that junction.

Seagrove Road. Between its junction with the east side of Stamshaw Road and a point 30 ft. east of that junction.

(B) PROHIBITION OF LOADING AND UNLOADING BETWEEN CERTAIN HOURS

(i) To prohibit the loading and unloading of vehicles between the hours of 8 a.m. and 9 a.m. on weekdays on the west side of Stamshaw Road between its northern junction with Twyford Avenue and its southern junction with Twyford Avenue.

(ii) To prohibit the loading and unloading of vehicles between the hours of 4.30 p.m. and 6 p.m. on weekdays on the following lengths of road—

Twyford Avenue

- (a) The east side between its northern junction with Stamshaw Road and its southern junction with Stamshaw Road.
- (b) The west side between its northern junction with Stamshaw Road and its junction with the north side of Gruneisen Road.

(c) The west side between its southern junction with Stamshaw Road and its junction with the south side of Simpson Road.

(C) ONE WAY TRAFFIC

To prohibit the driving of any vehicle along the undermentioned lengths of road otherwise than in the direction stated—

First Column Length of Road	Second Column Direction
Twyford Avenue, between its northern junction with Stamshaw Road and its southern junction with Stamshaw Road.	South to North.
Stamshaw Road.	North to South.

(D) MANDATORY RIGHT HAND TURNS

To prohibit vehicles making anything other than a right hand turn from the roads specified in the first column into the roads specified opposite to that road in the Second Column as set out below—

First Column	Second Column
Newcomen Road (east of Twyford Avenue).	Twyford Avenue.
Winstanley Road (east of Twyford Avenue).	Twyford Avenue.
Meyrick Road (east of Twyford Avenue).	Twyford Avenue.
Knox Road (east of Twyford Avenue).	Twyford Avenue.
Lower Derby Road (east of Twyford Avenue).	Twyford Avenue.
Lower Derby Road (west of Stamshaw Road).	Stamshaw Road.
Wilson Road (west of Stamshaw Road).	Stamshaw Road.

(E) MANDATORY LEFT HAND TURNS

To prohibit vehicles, except for Corporation Passenger Transport vehicles in service wishing to proceed from Derby Road to Lower Derby Road, making anything other than a left hand turn from the road specified in the First Column into the road specified opposite to that road in the Second Column as set out below—

First Column	Second Column
Wilson Road (west of Twyford Avenue).	Twyford Avenue.
Newcomen Road (west of Twyford Avenue).	Twyford Avenue.
Winstanley Road (west of Twyford Avenue).	Twyford Avenue.
Meyrick Road (west of Twyford Avenue).	Twyford Avenue.
Knox Road (west of Twyford Avenue).	Twyford Avenue.
Lower Derby Road (west of Twyford Avenue).	Twyford Avenue.
Derby Road.	Stamshaw Road.

Exceptions are provided in these proposals which will allow a vehicle to wait to enable:

- (i) a person to board or alight from the vehicle;
- (ii) the vehicle to be used in connection with any building operation or work on in under or adjacent to the lengths of road;
- (iii) postal packets to be collected or delivered by General Post Office vehicles;
- (iv) the vehicle to take in petrol, oil, water or air from any garage on or adjacent to the lengths of road;
- (v) vehicles used by registered Medical Practitioners to wait while they are engaged upon their professional duties;
- (vi) furniture removers to remove furniture from premises adjoining the lengths of road set out in part B of the proposals at times when the loading and unloading of goods would otherwise be prohibited providing they give 24 hours notice to the police and comply with any reasonable police requirements.

If these proposals are approved the Order will operate for a period not exceeding three months unless the appropriate Minister approves an extension for a further period of up to fifteen months. Existing Orders will also be revoked or amended where necessary.
