Stopping Up of Highways

CONFIRMATION OF PUBLIC PATH ORDER

Maidstone Rural District Council (Footpath No. 115 Boughton Monchelsea) Diversion Order, 1966

Notice is hereby given that on the 21st day of September 1966, the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to divert part of a public right of way starting from a point situate at the north-east corner of Hogtrough Shaw south of Brishing Road, Boughton Monchelsea (O.S. Parcel 33 Kent Sheet XLII.16 Revision of 1933) and running in a north-easterly direction for approximately 90 yards to Brishing Road, Boughton Monchelsea; to a footpath running in a north-westerly direction for approximately 20 yards to the north-western corner of Hogtrough Shaw and thence in a north-easterly direction along a line adjacent to the western boundary of O.S. Parcel 32 for approximately 80 yards to a stile at Brishing Road. The path will be diverted from 13th October 1966.
