Notice is hereby given that the Solihull County Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 26th day of May 1966, made three Orders entitled "The Solihull Smoke Control Order (No. 11), 1966", "The Solihull Smoke Control Order (No. 12), 1966" and "The Solihull Smoke Control Order (No. 13), 1966", declaring the areas described in Schedules hereto to be smoke control areas which Orders are about to be submitted to the Minister Orders are about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exceptions provided by the Orders and by virtue of section 11 (4) of the Act, if, on any day after the Orders have come into operation, smoke is emitted from a chimney of any building within the smoke control areas, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding $\pounds 10$ unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Orders will not come into opera-tion before the 1st day of September 1967, or such later date as may be determined by the Minister of Housing and Local Government.
