The Minister of Transport has made an Order under section 26 of the Road Traffic Act, 1960 the effect

section 26 of the Road Traffic Act, 1960 the effect of which is to prohibit waiting on that length of the London—Folkestone—Dover Trunk Road (A.20) at Addington in the Rural District of Malling, Kent, between its junction with Plowender Bridge Road and a point 192 yards east of that junction.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

The Trunk Road (Dorchester) (Prohibition and Restriction of Waiting) (No. 2) Order 1966

The Minister of Transport has made an Order under sections 26 and 28 of the Road Traffic Act 1960 the effect of which is:

- 1. to prohibit waiting between the hours of 8 a.m. and 6 p.m. on any day during the period commencing on the 1st October and ending on the 31st May the following year, in any of the lengths or on any of the sides of road specified in Schedule 1 hereto; and
- 2. to prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m. on any day during the period mentioned above on any of the sides of road specified in Schedule 2 hereto for a longer period than 20 minutes in any one hour.

The existing Prohibition of Waiting Order applying The existing Prohibition of Waiting Order applying to these lengths and sides of roads provides for alternating unilateral waiting during the period commencing on 1st October and ending on the 31st May the following year. The existing prohibition of waiting during the period commencing on the 1st June and ending on the 30th September will remain. Exceptions will continue to be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to heard or alight from the

be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
