#### TOWN AND COUNTRY PLANNING ACT 1962

#### HIGHWAYS ACT 1959

##### *The London—Fishguard Trunk Road (Cardiff Inner By-Pass) (Side Roads) Order 1966*

The Secretary of State hereby gives notice that in relation to the above-mentioned Trunk Road at Cardiff in the county of Glamorgan, he has made under section 9 of the above Act an Order, the effect of which will authorise the Secretary of State—

- (a) to improve, raise, lower or otherwise alter highways,
- (b) to stop up highways,

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Highways Act 1959, or on the ground that any requirement of that Act, or of regulations made thereunder has not been complied with in relation to the Order, may, within six weeks from 21st October 1966 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
