Others will be sited at suitable points chosen to accord with redevelopment expected to take place in due course on sites outside the area and adjacent to it on the other side of the circumambient roads. Meanwhile light-controlled pedestrian crossings will be provided in Hay- market and Charles Street. Pedestrians will be discouraged from crossing the streets round the area at unauthorised points."	As agreed by the local planning authority to meet the require- ments of the Ministry of Transport.
2.	Paragraph 4E. (W.S.) Delete the sub-title and the whole para- graph insert new sub-title and a new paragraph (such as):— "E. Vehicular Entry, Egress and Internal Circulation. Bread Street will be closed as a thoroughfare before the area is re- developed. On the line of Bread Street, a service court will be provided for vehicles. Vehicles will be able to enter and leave the court both by way of Charles Street and of Belgrave Gate. In Charles Street, the central reservation will be extended to prevent vehicles approaching from the north and turning right into the area and also to prevent vehicles emerging from the area and turning south. Correspondingly, vehicles will be able to enter the area from the north by way of a left turn from Belgrave Gate, and to turn left from the area southwards into Belgrave Gate. Right turns into or out of the area from Belgrave Gate will be discouraged. From the service court, upward ramps will lead to overhead car parks and downward ramps to under- ground service roads and unloading areas."	As agreed by the local planning authority to meet the require- ments of the Ministry of Transport.
3.	Paragraph 6 (W.S.) Add an extra sentence after "Minister":— "The footbridge across Humberstone Gate and the light- controlled pedestrian crossings in Charles Street and Haymarket will be brought into use at least as soon as the proposed new buildings (other than Messrs. Littlewoods' new premises)."	As agreed by the local planning authority to meet the require- ments of the Ministry of Transport.

Any objection to the modifications should be sent in writing to The Secretary, Ministry of Housing and Local Government, Whitehall, S.W.1 before the 18th November 1966 and should state in full the reasons for the objection and identify the land to which it relates.
