THE TRUNK ROAD (HAVERFORDWEST) (ONE-WAY AND RESTRICTION OF WAITING) **ORDER 1966**

Notice is hereby given that the Secretary of State intends to make an Order under sections 26 (1), (2) and (3) and 28 (1) of the Road Traffic Act 1960 and under section 48 of the Road Traffic Act 1962, the effect of which will be:

1. to revoke the Trunk Road (Cartlett Road, (Haverfordwest) (Prohibition and Restriction of Waiting) Order 1963, and the Trunk Road (Haverfordwest) (One-Way Traffic and Restriction of Waiting) Experimental Order 1965.

2. to prohibit the driving of any vehicle in that length of the Haverfordwest-Milford Haven Trunk Road (A.4076), known as Picton Place, New Bridge, Victoria Place, Castle Square, High Street and Dew Street, in the borough of Haverfordwest in the county of Pembroke, which lies between the junction of Picton Place with Salutation Square and the junctions of Dew Street with Albert Street and Shipman's Lane in a direction other than from north-east to southwest.

3. to prohibit any vehicle proceeding north-eastward in that length of the Haverfordwest-Milford Haven Trunk Road (A.4076), known as Milford Road, in the borough of Haverfordwest in the county of Pembroke, from making a right-hand turn into Shipman's Lane in that borough and county.

4. to modify the Orders specified in each of the following paragraphs as provided in that paragraph

(I) The County of Pembroke (Haverfordwest) (Traffic Regulation) Order 1956, shall have effect as though-

(a) in Article 1, after the word "wait: - " for all the words following that word to the end of the Article, there were substituted the words " on the side of road specified in the Schedule to this Order.";

rder."; (b) in Article 2— (i) for the words "any of the sides of road specified in that Article", there were sub-stituted the words "the side of road referred to in that Article"; and (ii) in paragraph (c), for the words "any of the sides of road so specified" and the words "any of the sides of road", there were substituted respectively the words "the side of road so referred to" and the words "the said side of road"; (c) in the First Schedule—

(II) The Trunk Roads (Various Streets, Haverford-west) (Restriction of Waiting) Order 1960 shall

(a) in Article 1 (a), for the words "in any road or length or part of a road", there were substituted the words "either road, the length of road or either part of road";
(b) in Article 1 (b), for the words "in any part of a road", there were substituted the words "either road, the length of road or either part of road";
(b) in Article 1 (b), for the words "in any part of a road", there were substituted the words "in the part of road";
(c) in Article 2—

(i) for the words "in any road or length or part of a road", there were substituted the words "in either road, the length of road or any part of road"; and
(ii) in paragraph (c), for the words "the road or length or part of a road" where these words twice occur, there were substituted the words "that road or length of road or part of road or length of road or part of road"; of road "

of road"; (d) in the First Schedule the heading "The Haverfordwest-Milford Haven Trunk Road (Route A.4076)" and all the items under that

heading were omitted; and (e) in the iterits under that (e) in the Second Schedule, under the heading specified in sub-paragraph (d) of this paragraph, items 1 and 2 were omitted.

5. to prohibit waiting: (a) on any of the sides of road specified in Schedule 1 below; and

- (b) between the hours of 8 a.m. and 6 p.m. on any of the sides of road specified in Schedule below

(i) for a longer period than one hour; or (ii) if a period of less than one hour has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on that side of road.

Exceptions will be provided in the Order to enable vehicle to wait for so long as may be necessary for a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in con-nection with any building operation or demolition, the removal of any obstruction to traffic, the main-tenance of the road or the services therein.
