#### CORNWALL COUNTY COUNCIL

##### *The County of Cornwall (Port Isaac) (Various Streets) (Prohibition of Waiting) Order, 1966*

Notice is hereby given that on the 20th October 1966 the Cornwall County Council made an Order under sections 26 and 27 of the Road Traffic Act, 1960, the effect of which is:

1. To prohibit the waiting of vehicles during the period 1st May-30th September (both dates inclusive) in each year on the lengths of road specified in the First Schedule hereto.
2. To amend the County of Cornwall (Port Isaac) (Prohibition of Waiting) Order, 1963, as amended by the County of Cornwall (Port Isaac) (Prohibition of Waiting) (Amendment) Order, 1965, by which the waiting of vehicles is prohibited, with certain exceptions, during the period 1st June-30th September in each year on the lengths of road specified in the Second Schedule hereto, so that in future the restrictions contained therein shall operate during the period 1st May-30th September (both dates inclusive) in each year.

Exceptions are provided in the Order to allow a vehicle to wait for so long as may be necessary to allow a person to board or alight from the vehicle; to enable goods to be loaded or unloaded; to enable vehicles to be used in connection with building operations, the maintenance or improvement of the lengths of road or of the services therein; to take in petrol, oil, water or air from a garage and in connection with a funeral.

The Order will come into operation on the 1st May 1967.

#### FIRST SCHEDULE

##### *Lengths of road at Port Isaac in the Parish of St. Endellion*

- (i) Back Hill (Class III)—between its junction with New Road (B.3267/Class III) and its junction with Fore Street (Unclassified).
- (ii) Middle Street (Unclassified)—throughout its length from its junction Fore Street (Unclassified).
- (iii) Dolphin Street (Unclassified)—throughout its length from its junction Middle Street (Unclassified).
- (iv) New Road (B.3267)—between its junction with Trewetha Lane (Unclassified) and its junction with Back Hill (Class III).
- (v) New Road (Class III)—from its junction with Back Hill (Class III) for a distance of 100 yards in an easterly direction.
- (vi) Trewetha Lane (Unclassified)—between its junction with New Road (B.3267) and its junction with Back Hill (Class III).

#### SECOND SCHEDULE

##### *Lengths of road at Port Isaac in the Parish of St. Endellion*

- (i) Fore Street (Unclassified)—from its junction with the Class III Road at the entrance to the Coast-guard Station in a westerly and southerly direction to its junction with the Class III Road at Port Isaac School.
- (ii) The Class III Road from its junction with the Unclassified Road at Port Isaac School in a general southerly direction to a point nine yards south of the telephone kiosk in Church Hill, Port Isaac.
- (iii) The Port Isaac-Portgaverne Road (Class III)—from the eastern boundary of the Tre-Pol-Pen Hotel for a distance of 168 yards in an easterly direction.
