Corporal Varley has commanded his section in a series of successful operations in Borneo.

On the 16th March 1966, he took part in an attack on a strong base position set up by part of an infiltrating enemy company. During the night Corporal Varley skilfully moved his section to within twelve yards of the position, and lay there undetected until dawn. He then opened fire on the position, controlling the fire of his section in the face of accurate enemy retaliation. At a crucial stage the section general purpose machine gun jammed and the section was in danger of losing the initiative to an enemy Browning machine gunner who now became active at very close range. Corporal Varley at once threw smoke grenades and withdrew his section to a bank about fifteen yards to his rear, and from there gave new fire control orders to win back the fire fight knowing that he had to keep the enemy engaged for a further fifteen minutes to enable other parts of the overall plan to succeed. Corporal Varley succeeded in his mission and was finally ordered to withdraw. It was largely due to his courage, coolness under fire, and tenacity that this part of the plan succeeded and the platoon was finally able to break off contact after inflicting heavy losses on the enemy at the cost of only two casualties.

The QUEEN has been graciously pleased to approve the undermentioned awards in recognition of gallant and distinguished services in the Borneo Territories during the period 24th December 1965 to 23rd June 1966.

Distinguished Service Order

Captain (temporary Major) Christopher James PIKE (433572) 10th Princess Mary's Own Gurkha Rifles.

On 5th March 1966, in Sarawak, Major Pike was ordered to ambush a frequently used enemy incursion route. While personally reconnoitring for his three platoons he located an enemy patrol base close to the track. He realised that an ambush so near the enemy base would probably surprise the enemy and boldly planned accordingly. The ambush position was skillfully occupied without alerting the enemy and at 1700 hours that evening, a party of some 35 regular Indonesian troops moved up the track. The ambush was sprung devastatingly and 28 enemy were killed. Reaction was immediate; mortar and automatic fire from the enemy base swept the

ambush area and Major Pike ordered his right hand platoon to withdraw to the Company rendezvous covered by the two platoons on the left. An enemy party, probing forward on this flank, was successfully engaged, 9 being killed in the space of two minutes. Under further mortar and automatic fire Major Pike coolly directed the regrouping of his company through a series of pre-selected bounds.

On 24th March 1966 Major Pike again located an enemy incursion party. Enemy patrols were in the area of D Company's base which had been sited with a view to concealment only and one party of twelve sat for six hours on the small track leading into the Company's "hide". Major Pike stood his Company to and then calmly assessed the disadvantageous situation he now found himself in. He decided that a night move was called for and, to enable this to be carried out quietly, the evening and early part of the night was spent in clipping an exit route through the thick secondary jungle. Major Pike then led his men in a brilliantly executed night march, starting at 0300 hours, and shortly after first light had established three posts covering a complex of tracks leading to the border. By so doing he had completely wrested the initiative from the enemy. At 1030 hours, 25 enemy approached the position and in a fierce engagement in secondary jungle, much of it at five yards range 13 enemy were killed. D Company had four men killed, and two wounded. With these casualties to be dealt with and continuous, if indiscriminate, enemy fire still sweeping the ambush area the Company might well have faltered but Major Pike, showing a high degree of confident and aggressive leadership, maintained a complete grip on the situation, coolly regrouping his force and retaining the initiative in the battle area until the enemy were silenced and fled.

In the space of three weeks Major Pike's company killed some 50 regular Indonesian troops in two fierce battles. The efficiency and high morale of the company is a reflection of Major Pike's leadership and tactical sense. His personal courage and coolness under fire have been outstanding, an example and inspiration to all ranks of the Battalion.

Military Cross

Major John Aidan PEEL (430413) Royal Regiment of Artillery.

Captain (now Major) Peel acted as Forward Observation Officer in seven operations on the Sarawak border between December 1965 and April 1966, in support of the Second Tenth, and latterly the First Tenth, Princess Mary's Own Gurkha Rifles. On all these occasions the forces involved were subjected to frequent mortar and artillery harassing fire.

In late December 1965, Captain Peel was forward observation officer for a small force, commanded by a junior Queen's Gurkha officer, tasked to ambush a known enemy incursion track. The operation involved close reconnaissance of an enemy border post and meticulous planning, in all of which Captain Peel played an important part. The ambush, successfully sprung, resulted in the killing of nine enemy. The enemy reacted violently and fired some 200 mortar bombs at our troops. Under this fire, and whilst withdrawing quickly through jungle, Captain Peel repeatedly stopped to set up his aerial and call for our own gunfire, and though unable to silence permanently the enemy mortars, neutralised them sufficiently to enable the force to regroup successfully without casualties. In doing this he displayed calmness and persistence under very hard conditions.

On three operations in February and March, 1966, Captain Peel was again subjected to enemy fire and on one occasion occupied for three days an isolated hill top observation post in full view of the enemy where the slightest unconsidered movement would have invited retaliation by fire.

During all these operations Captain Peel directed his guns skillfully in the most difficult and arduous circumstances. By his coolness and courage under fire Captain Peel has won for himself a very high reputation with the Officers, Non Commissioned Officers and Riflemen of two Gurkha Battalions.

Military Cross

Lieutenant Douglas William Fox (471256), Royal Regiment of Artillery.

In the Bau District of Sarawak Lieutenant Fox was acting as Forward Observation Officer to C Company 2nd/10th Princess Mary's Own Gurkha Rifles when the company located and attacked a

large enemy force near the border. Before the company moved forward to their assault position Lieutenant Fox, accompanied only by his signaller and two Gurkha soldiers, moved independently to a location well forward of the company and very close to the enemy position, from which he could observe not only the immediate enemy but also all approaches to their position. This bold and hazardous move proved to be a vital factor in the subsequent battle and, but for the courage, leadership and determination shown in this preliminary phase by this officer, the casualties caused to the company would certainly have been more severe and the damage to the enemy much less conclusive.

During the battle Lieutenant Fox, from the excellent observation post he had personally established, was able to bring down on the enemy such devastating fire from the guns he was controlling that the final issue was never in doubt. Despite the heavy enemy mortar fire which was landing all round him and his very small group he continued throughout the action personally to man his post and was thus able to observe and eventually silence every enemy mortar position and also to bring down such effective fire on to the enemy counter attacking force that it was broken and dispersed before it could influence the result.

His outstanding conduct throughout the operation, his courageous contempt for the enemy fire and the example he set to those with him in their isolated and vulnerable position are deserving of high praise.

Military Cross

Major John Arthur Gordon ARNOT (369355), The Durham Light Infantry.

On 24th February 1966, Major Arnot was in command of a force of three platoons on the Kalimantan/Sarawak frontier. He deployed his force in an ambush position on 25th February 1966. At 1030 hours on 26th February 1966, the ambush was sprung accounting for eleven of the enemy.

In the ensuing action Major Arnot manoeuvred his company and directed the artillery fire with coolness and precision for two hours. When the action was broken off he conducted the withdrawal of the force with outstanding skill over a period of seven hours. The force always in danger of an enemy follow up and harried by mortar fire was hampered by carrying a dead man, and the seriously wounded. Throughout Major Arnot inspired his men by his complete command of the situation, his endurance, outstanding coolness and confidence in an operation that lasted for two days.

This incident is but one example of his fine leadership and daring as a company commander.

For five months he has commanded a forward base on the frontier. The sector of the front for which this base was responsible has been the most important and active in the Battalion's sector. Major Arnot has seldom had less than five platoons under his command. Not only has he directed the operations in his sector with imagination and drive, he has commanded his company in contact with the enemy with skill, coolness and resource.

Military Cross

Captain Christopher Darnley HUGHES (461453), 10th Princess Mary's Own Gurkha Rifles.

On the 15th February 1966, Captain Hughes was ordered to place his company in a series of ambush positions along a track to cut off an enemy force, estimated at 40 to 60 strong, that had crossed the border into the Tebedu area of First Division.

The ambushes were in position early on the morning of 16th February and Captain Hughes sent out patrols laterally and to his front to ensure that the enemy had not crossed the track by night and to locate the incursion party.

At 1215 hours one of the forward patrols was heavily engaged by the enemy about 1200 yards in front of the ambush line and threatened with encirclement. At the outbreak of firing Captain Hughes gathered the men that were immediately available and dashed to the aid of his patrol. He arrived as the enemy was about to encircle the patrol and although outnumbered he immediately attacked. In this engagement he suffered one man wounded but put the enemy to flight.

By this time more of his company had arrived and Captain Hughes immediately took up pursuit of the enemy. He caught up with the enemy at 1330 hours and again attacked, killing one before the remainder fled leaving behind quantities of equipment

and arms. From the blood-trails and blood-stained bandages found it was obvious that the enemy had suffered more casualties than the one killed.

Captain Hughes pressed on after the enemy in extremely difficult, close hilly country which gave every advantage for ambush and surprise to the enemy. At approximately 1745 hours in an open space some enemy were seen running from a low hill up on to a higher connecting feature. As there was only about an hour of daylight left Captain Hughes ordered an immediate attack.

Once the lower feature was breasted the two leading platoons came under very heavy automatic fire and found themselves in difficulty with plastic mines and booby traps that the enemy had laid. The attack was vigorously pressed but the company suffered two casualties on mines and a further two men wounded and one killed from automatic fire. The enemy had the advantage of height and any attempt to get forward or round the flanks of the position was met with heavy automatic and rocket launcher fire. The fight continued until after last light and the enemy escaped in the darkness leaving behind one dead and much equipment; most of it booby trapped.

As a result of the persistent attacks during the day the enemy split into small groups in an effort to avoid further harrying and so made his final elimination as a force easier and ensured the failure of his plan. Captain Hughes continued to patrol the area vigorously and cunningly and his efforts were further rewarded when he with a small party contacted and killed two enemy four days later.

Throughout the operation Captain Hughes displayed courage, skill, and endurance of a very high order and was an inspiration to those around him.

Military Cross

Captain (Q.G.O.) PURNASENG LIMBU, M.V.O. (463793), 10th Princess Mary's Own Gurkha Rifles.

On the 28th December in the Bau District of Sarawak, Captain (Q.G.O.) Purnasing Limbu was in command of 9 Platoon of C Company when they successfully ambushed and annihilated an enemy force located in the border area.

Some days earlier, accompanied by only three men, he located a well used enemy supply route and for three days remained in observation, gaining all possible information of the enemy's movements, strengths and routine. Rejoining his platoon he spent the following two days practising and rehearsing his men thus ensuring that, when his ambush was sprung, the maximum number of enemy would be eliminated. So well prepared were his platoon and so carefully sited that, during the following three days, when an enemy patrol came to within 15 yards of his ambush and two large groups of civilians walked through his position the alarm was not raised. Just after mid-day on the fourth day a large number of enemy were seen approaching the ambush and when the leading enemy was about to move out of the killing area he opened fire, himself killing the two enemy immediately in front of him. A total of nine enemy were killed instantly by the remainder of his platoon and two others were seriously wounded. Immediately the enemy in rear brought intense small arms fire to bear on the ambush and very soon two enemy mortars opened fire, the bombs landing on and around his position. He now showed outstanding personal bravery and leadership of the highest order. With a complete disregard for the enemy's fire he calmly moved from group to group, coolly directing their fire against the hidden enemy and inspiring all to give of their best. When, eventually, he decided to break contact to avoid risking heavy casualties he ensured that his orders for the withdrawal were heard above the noise and clearly understood by issuing them individually to every group in his platoon. He personally conducted every move by his sections, remaining with the rearguard until all had finally broken contact with the enemy.

He not only found the target but planned, led and executed the whole operation. It was in concept and in deed perfect in every detail. The aggressive spirit, initiative, determination, leadership and bravery shown by this officer was outstanding.

Distinguished Conduct Medal

21140375 Rifleman (Local Lance Corporal) HINDUPAL RAI, 10th Princess Mary's Own Gurkha Rifles.

On 25th March 1966, Lance Corporal Hindupal Rai was commanding a section of 10 Platoon D Company

1st Battalion 10th Princess Mary's Own Gurkha Rifles near the Sarawak border covering a complex of tracks to prevent the withdrawal of an enemy incursion party. Visibility was about three to ten yards.

At 1030 hours, approximately 25 regular Indonesian troops approached 10 Platoon's position, seven of them passing Lance Corporal Hindupal's post from right to left at a range of three yards. Coolly he allowed them to pass towards platoon Headquarters and a general purpose machine gun on his left. As the machine gun opened fire Lance Corporal Hindupal and his rifle group engaged three enemy to their front killing two. Within seconds, two more enemy advanced towards Lance Corporal Hindupal's position firing bursts. He shot them both dead at point blank range. Heavy automatic fire was now directed towards Lance Corporal Hindupal's section and a fierce fire fight ensued. By shouted fire orders, personal example and by crawling to the various groups of his section Lance Corporal Hindupal was able to prevent the enemy's approach to the platoon position from along the main track. The order was then given to break off the engagement. He ordered his light machine gun group to move first while he covered them. The sound of this movement attracted further well-directed automatic fire which wounded the light machine gun Number 1. Lance Corporal Hindupal at once engaged the enemy, silencing them temporarily and continued to cover the withdrawal of the light machine gun party. Now ordering the rifle group to withdraw, first one and then a second Rifleman were killed within a few yards of him as they moved to the rear. He again took on the enemy single handed and so ensured the safe withdrawal of the remainder of his men. He was the last man to leave the position and was in the act of changing his magazine when an enemy advanced towards him firing an automatic weapon. Lance Corporal Hindupal shot him dead at two yards' range.

He now withdrew to the Company rendezvous, and reported that since he had been forced to leave two of his dead in the ambush position while extricating the rest of the section, he wanted to go back to get them. In spite of the now confused situation and continued enemy fire aimed at the ambush area, he personally led two sections of his platoon back to his post to recover the bodies. It seemed at the time, and in retrospect still does, that this act called for the greatest courage of all.

In the action 13 enemy were killed; D Company lost 4 killed and two wounded. Lance Corporal Hindupal personally killed 5 enemy and dominated the action on the right flank of his platoon. His leadership, control, personal example, coolness and, above all, his courage throughout a fierce engagement at point blank range were outstanding.

Military Medal

21149520 Rifleman (acting Lance Corporal) MANBAHADUR THAPA, 2nd King Edward VII's Own Gurkha Rifles (The Sirmoor Rifles).

Lance Corporal Manbahadur Thapa was No. 1 on a general purpose machine gun attached to the right assault platoon of a company during an attack on an enemy defended camp in Borneo. Whilst moving into position prior to the assault the enemy opened fire on the left assault platoon and his machine gun team was ordered to take up a fire position in secondary jungle, overlooking the objectives, and opened effective fire on both targets. No sooner had fire been opened however, than Lance Corporal Manbahadur's platoon was also engaged by heavy enemy fire including medium machine guns and 60 mm. mortar. The second mortar bomb exploded just behind the platoon causing four casualties including Lance Corporal Manbahadur who received a large shrapnel wound in his back. He continued however to engage the enemy with his machine gun and only when the position was taken did he allow himself to receive medical attention.

Throughout the battle and in spite of his wounds Lance Corporal Manbahadur with complete disregard for his personal safety, maintained contact with the enemy and his stamina and cheerfulness until he collapsed from his wounds were a source of inspiration to the men in his platoon.

On another occasion Lance Corporal Manbahadur was ordered to take up a fire position at the edge of secondary jungle on the steep bank of a river and engage the enemy on the other side. No sooner had fire been opened than the Support Group came under medium machine gun fire from an undiscovered

enemy position approximately 100 yards north of the first camp. Unable to engage this second target from his present position due to the jungle growth Lance Corporal Manbahadur, without orders and with extreme coolness, moved on to the open shingle at the edge of the river and without any form of cover engaged the new enemy position with his 2 inch mortar until the enemy medium machine gun had been silenced.

Through the initiative of Lance Corporal Manbahadur the company was able to continue the assault into the midst of the enemy position and the eventual success was attributable to his gallantry and coolness.

Military Medal

21140853 Corporal ASMANI RAI, 10th Princess Mary's Own Gurkha Rifles.

In the Bau District of Sarawak, Corporal Asmani Rai commanded a section of the Reconnaissance Platoon, his section fought against on more occasions and killed more of the enemy than any other in the battalion. In all of these actions Corporal Asmani displayed such courage, determination and aggressive leadership that he was singled out for personal commendation by his various commanders. In two separate attack operations in the Serikin area and later in the Gumbang area he acquitted himself with distinction. He led his section in the prolonged close quarter fighting through the enemy position, moving through the intense enemy fire without regard for his own safety and personally killing four of the enemy. His conduct throughout the battle was a superb example of junior leadership allied to great personal bravery and aggressive, dogged determination. Corporal Asmani was selected for and successfully completed a most hazardous and prolonged reconnaissance patrol. Accompanied by only three others of his section he gained the most detailed information of the enemy dispositions, strength and movement which proved to be of the greatest value and led subsequently to a successful operation against the enemy lines of communication.

Corporal Asmani has on more than one occasion, in the face of the enemy, shown great bravery and inspired leadership which have earned him a fighting reputation second to none.

Military Medal

21148768 Rifleman (local Lance Corporal) JAGATBAHADUR LIMBU 10th Princess Mary's Own Gurkha Rifles.

On 5th March 1966, Lance Corporal Jagatbahadur Limbu was the general purpose machine gun gunner in 11 Platoon, D Company, 1st Battalion 10th Princess Mary's Own Gurkha Rifles and played a prominent part in a highly successful ambush near the Sarawak border following an incursion by regular Indonesian troops.

Lance Corporal Jagatbahadur with his general purpose machine gun was placed on the left flank of his platoon ambush position and it was from the left that an enemy party, some 35 strong, approached. The leading group, bunched and unsuspecting, passed him and at a range of twenty yards he opened fire devastatingly, enflading them and causing many casualties. Reloading, he then moved round behind the troops on his right into the centre of the position and raked the ambush area again, this time from some ten to fifteen yards range. As the enemy now tried to move out of the ambush area, he again ran down the position towards the right flank in full view of the enemy to engage them, firing his machine gun from the hip into a group at point blank range until there were no targets in sight. Lance Corporal Jagatbahadur fired some 400 rounds from his machine gun, of a total of not less than 28 enemy killed in the ambush there is little doubt that he was personally responsible for killing more than 50 per cent.

The enemy from a nearby position now opened fire on our troops in ambush using automatics and mortars, and 11 Platoon was ordered to move back to their rendezvous. Lance Corporal Jagatbahadur remained with his platoon commander giving covering fire until the last of our men were clear of the area.

During the action, lasting ten minutes, Lance Corporal Jagatbahadur displayed complete disregard for his own safety in his determination to get to grips with the enemy. The success of the operation was due in large measure to his courage and aggressive spirit.
