### PRICES AND INCOMES ACT 1966

*Distribution Costs of Fresh Fruit and Vegetables*

*Direction under section 5 (4) Extending the Period within which the National Board for Prices and Incomes must Publish Their Report*

Whereas the First Secretary of State and the Minister of Agriculture, Fisheries and Food, in pursuance of their powers under section 2 (1) of the Prices and Incomes Act 1966, referred the above-mentioned

question to the National Board for Prices and Incomes for examination and have published the text of the reference in the Gazette on 6th October 1966;

2. And whereas by section 5 (3) of the Act, but subject to section 5 (4), the Board are required to make their report so as to allow publication within three months of the said date;

3. Now therefore, the First Secretary of State and the Minister of Agriculture, Fisheries and Food, in pursuance of their powers under the said section 5 (4), hereby direct that the said period of three months be extended by two months.
