EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY

Commons Registration Act, 1965

Notice of Grant of Exemption Order

The Minister of Land and Natural Resources has, upon the application of the Mitcham Common Conservators, 794A London Road, Thornton Heath, Surrey, made an Order under section 11 of the Commons Registration Act, 1965, exempting the land of which particulars are given below from registration under the Act.

In consequence, the registration provisions of the Act will not apply to this land. However, land that is common land or a town or village green does not cease to be so because an order has been made in respect of it, nor are the rights or interests of any person in the land prejudiced by the Order.
