 (a) they are signed or attested by a Solicitor of the Supreme Court, or
 (b) the Praccipe relating to the advertisement is produced for inspection at the time the advertisement is submitted, or

(c) a duplicate Praecipe relating to the advertisement is produced for retention by The London Gazette Office.

Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.

(b) Notices under the Companies Act, 1948:
(i) Notice of Appointment of Liquidator pursuant to Section 305 of the Act and the Companies (Forms) Order, 1949 (S.I. 1949 No. 382): 10s. 0d.
(ii) Notice of Advertisement of Petition pursuant to Rule 28 of the Companies (Winding-up) Rules, 1940 (S.I. 1940 No. 323): 10s. 0d.

(iii) Notice pursuant to the Companies (Board of Trade) Fees Order, 1963 (S.I. 1963 No. 467): 10s. 0d.
