The QUEEN has been graciously pleased to approve the award of the George Medal to the undermentioned :

Major Henry Percival QUALTROUGH, M.B.E. (304206), Corps of Royal Engineers (Now retired).

1906111 Sergeant Horace Edward Cooke, B.E.M., Corps of Royal Engineers.

Major Qualtrough and Sergeant Cooke undertook a reconnaissance of the notorious Japanese bomb and sea mine dumps on Penang Island after which they cleared about one hundred tons of bombs' and shells from Japanese bunkers on the Island of Betio in the Gilbert and Ellice Islands. Their drive and complete disregard of personal safety were the two factors which led to the completion of these two difficult tacks in the short time available. On Penang factors which led to the completion of these two difficult tasks in the short time available. On Penang Island they located tunnels and covered trenches at nine major sites and excavated and removed for analysis samples of bombs and mines from each site. The dangers included the possibility of the formation of most dangerous unstable picrate crystals from picric fillings, the presence of corroded and unsafe fuzes and the likelihood of very dangerous copper azide formed from the lead azide in detonators. Well tranving the risks involved they entered a tunnel azide formed from the lead azide in detonators. Well knowing the risks involved they entered a tunnel which had partially collapsed and was in imminent danger of further roof falls and removed 60 kg Japanese bombs which in addition to damage by roof falls had been subject to years of corrosion. On Betio Island about forty Japanese bunkers were ex-cavated and cleared. These bunkers had been sealed by dozing during a previous clearance shortly after the war, but remained a serious danger to the inhabi-tants of this highly populated island. Their clearance and the detector search and clearance of the whole tants of this highly populated Island. I her clearance and the detector search and clearance of the whole island including a coral causeway produced about one hundred tons of Japanese and American bombs and shells many of which were fuzed or in a state of critical decomposition. At all times during these hazardous tasks Major Qualtrough and Sergeant Cooke displayed the highest standard of courage and shill skill.

The QUEEN has been graciously pleased on the advice of Her Majesty's Australian Ministers to approve the undermentioned awards in recognition of gallant conduct in Vietnam with effect from 29th December 1966:

Distinguished Service Order

Brigadier Oliver David JACKSON, O.B.E. (2111), Australian Staff Corps.

Brigadier Oliver David Jackson graduated from the Royal Military College in December 1939 in the Royal Australian Infantry. In May 1966 he was

appointed Commander 1st Australian Task Force which was deployed on active service in Phuoc Tuy Province of South Vietnam commencing in June 1966. This appointment immediately followed a period of 15 months of distinguished service in Vietnam as Commanding Officer Australian Army Training Team Vietnam and Commander Australian Army Force Vietnam. He successfully planned and executed the deployment into operations of the Task Force following its arrival from Australia. This was accomplished despite unfavourable weather conditions and logistical and operational problems of considerable magnitude which demanded his constant personal attention. attention.

attention. Following initial deployment he personally directed and controlled the operations of the Task Force in Phuoc Tuy Province with conspicuous success. In one action on 18th August 1966 he personally directed the engagement which accounted for 254 enemy dead by body count with very light comparative losses to his own troops. His able personal direction was a decisive factor in obtaining an extremely favourable outcome in very difficult circumstances. Throughout his period of command of the Task Force his professional skill and leadership has been outstanding and he has developed excellent relations with the allied formations with which the Task Force is associated. His consideration of his troops without thought for

His consideration of his troops without thought for himself and his personal example have been an inspiration to those under his command.

Military Cross

Major Harry Arthur SMITH (6776), Australian Staff Corps (Royal Australian Infantry).

Major Harry Arthur SMITH was commissioned from the Officer Cadet School on 13th December 1952 and first saw active service with 2nd Battalion The Royal Australian Regiment during the Malaya Emergency 1955-1957.

In August 1966 Major Smith commanded D Com-pany 6th Battalion The Royal Australian Regiment. On 18th August 1966 D Company began a Search and Destroy Patrol in Phuoc Tuy Province, South Vietnam.

Vietnam. During the patrol the leading platoon contacted what appeared to be a small Viet Cong patrol in thick rubber. The enemy soon proved to be the vanguard of a regimental size force, and the platoon engagement quickly developed into a company battle. The Viet Cong attacking from two flanks and supported by intense mortar and recoilless rifle fire, score paragrated between the leading platoon and the soon penetrated between the leading platoon and the rest of the company.

Despite the intense and accurate enemy fire Major Smith formed the remainder of his company into a small defensive perimeter from which he made

repeated but unsuccessful attempts to relieve the leading platoon; whilst halting numerous attacks from both flanks on his own position. Throughout the action he directed the fire of his company and of his supporting artillery batteries with such effectiveness that the enemy finally dis-engaged and withdrew, leaving behind over two hundred dead. hundred dead.

But for the determination and outstanding leader-ship shown by this officer, D Company might well have been annihilated.

During the whole of the engagement he had com-plete control of the situation. He exercised his com-mand with calmness, determination and confidence, and demonstrated professional competence, leadership and demonstrated professional competence, leadership and inspiration to an exceptional degree. There is no doubt that his leadership and his disregard for his own personal safety inspired his soldiers to a performance of duty of a high order. His display of command, leadership and professionalism is an inspiration to all.

nd Lieutenant Peter John SCHUMAN (214124), Australian Staff Corps (Royal Australian Infantry). 2nd Lieutenant

On 14th July 1966 Second Lieutenant Peter John Schuman in command of a reconnaissance patrol comprising four all ranks departed the operational base at Nui Dat YS4367 South Vietnam. The mission of

at Nui Dat YS4367 South Vietnam. The mission of the patrol was to locate and keep under surveillance a suspected Viet Cong Base camp. At 1040 hours on 17th July 1966, a camp contain-ing Viet Cong was located at grid reference 507668. During close reconnaissance of the camp the patrol was sighted. As the sentry took aim, Second Lieutenant Schuman felled him with rifle fire and withdrew his patrol, under heavy fire from the camp, for about fifty metres.

for about fifty metres. Appreciating that his mission had been com-promised Second Lieutenant Schuman shook his four promised Second Lieutenant Schuman shook his four man patrol into extended line and assaulted the camp with small arms fire and grenades. He drove the enemy from the camp and then proceeded to search the area. The patrol recovered large quantities of documents and equipment. Having assessed what items of value could be carried, he then destroyed all the remaining equipment and the camp buildings by fire. by fire.

by fire. His progress during withdrawal was slowed by the amount of enemy equipment the patrol was carrying and because he had reason to suppose he was being tracked, Second Lieutenant Schuman requested heli-copter evacuation. At 1550 hours whilst securing the landing zone at grid reference 511668 two Viet Cong were sighted approaching the area. To ensure killing the enemy, Second Lieutenant Schuman with-held his order to fire until the enemy was within ten metres. One Viet Cong was killed and his weapon and equipment recovered. The other was severely wounded and went to ground. The imminent arrival of the helicopter prevented follow up. arrival of the helicopter prevented follow up.

Distinguished Conduct Medal

27758 Sergeant (temporary Warrant Officer Class II) John William Kirby, Royal Australian Infantry.

Warrant Officer John William Kirby was the Com-pany Sergeant Major of D Company Sixth Battalion The Royal Australian Regiment during the battle of Long Tan in the Republic of South Vietnam on 18th August 1966. Warrant Officer Kirby showed outstanding bravery throughout the three hours of the outstanding bravery throughout the three hours of the battle, during which time the Company area was being swept with machine gun and small arms fire, and subjected to continuous attacks by superior Viet Cong forces. In an area where virtually any move-ment resulted in a hail of fire from the enemy, he continually moved around the company and platoon continually moved around the company and platoon areas, distributing ammunition and organising the collection of the wounded and their movement to the Company Aid Post. At times he went outside the perimeter to assist the evacuation of the wounded from the forward platoons. At one stage he per-sonally destroyed a heavy machine gun post being set up 50 metres from the perimeter. He organised the resupply of ammunition by heli-copters and continued with the distribution of ammu-nition and movement of the wounded until the Com-

nition and movement of the wounded until the Com-pany was relieved. Then, when most of the Com-pany could relax, he continued working at full pressure for another five hours, organising and supervising the loading and evacuation of the casualties

His gallant performance, without any thought for his own safety inspired and assisted D Company

to defeat an enemy force much larger than the company.

Military Medal

55106 Corporal (temporary Sergeant) Robert Stanley BUICK, Royal Australian Infantry.

Sergeant Robert Stanley Buick was Platoon Ser-geant of 11 Platoon D Company Sixth Battalion The Royal Australian Regiment.

The Royal Australian Regiment. During the early stage of an engagement at Long Tan in The Republic of Vietnam on 18th August 1966 the platoon commander was killed. The platoon was almost surrounded by a numeri-cally superior Viet Cong force and had suffered a large number of casualties from small arms and mortar fire. Sergeant Buick assumed command, rallied the remaining fourteen members of 11 Platoon and fought off further enemy attacks. Realising that the platoon was in danger of being overrun and that the other platoons were under heavy fire themselves he decided to fight his way back to the company. On his orders and covered by fire from the remainder of the company, the platoon broke through the enemy fire and rejoined D Com-pany. Sergeant Buick remained with the last group pany. Sergeant Buick remained with the last group to cover the withdrawal. Throughout the action Sergeant Buick showed out-

standing leadership, personal courage and a fine sense of military judgment.

17693 Corporal Robert Boyd Dale RUTHERFORD, Royal Australian Infantry.

On 25th July 1966 Sixth Battalion The Royal Australian Regiment was engaged on a Search and Destroy Operation in Phuoc Tuy Province, South Vietnam. Corporal Rutherford was a Section Com-mander in D Company. In the early afternoon of that day an enemy force of well-trained and well-led Viet Cong guerilla forces

contacted D Company in a hastily organised position.

Corporal Rutherford's platoon bore the brunt of the subsequent enemy attacks and suffered during the short fierce engagement ten casualties, including the Platoon Sergeant. Corporal Rutherford, on his own initiative, immediately took over as platoon sergeant.

During the close and very heavy fire fight and mor-taring which ensued, he moved with complete dis-regard for his own safety around the weapon pits tending to the casualties and the administration of the platoon.

He moved forward to assist a wounded soldier but was driven back by heavy fire falling around him. Nevertheless he persevered and again moved forward to dress the wounds of the casualty and pulled him back to his own shell scrape for safety. He con-tinued to assist the wounded in this manner.

In addition he took on himself the task of distributing ammunition to those positions where am-munition was running low, and exposed himself to enemy fire whilst doing so. Throughout the action he continued to control fire and give orders in such a calm and confident manner as to inspire and encourage the men under

his command.

Corporal Rutherford's actions were outstanding and he took far greater risks with his life than his duties as a section commander required. His inspiration to all present by his actions and his timely and effective treatment of the casualties deserve permanent recognition.

173094 Private Ronald Maxwell EGLINGTON, Royal Australian Infantry.

Private Ronald Maxwell Eglington was a machine gunner with 11 Platoon D Company Sixth Battalion The Royal Australian Regiment at Long Tan in The Republic of South Vietnam on 18th August 1966 Republic of South Vietnam on 18th August 1900 when the platoon was attacked by a superior enemy force. Although wounded early in the action, he remained at his post and provided fire, engaging attack after attack until his gun stopped choked with mud. He withdrew with the platoon to the Com-pany position and under fire stripped, cleaned, and reassembled his machine gun

reassembled his machine gun. Although wounded, by his outstanding devotion to duty and disregard for his own safety Private Eglington was instrumental in preventing the Viet Cong from overrunning 11 Platoon.
